STANDING ITEM: CONSIDERATION OF POTENTIAL STUDY ISSUES

4 <u>22-1018</u> Discussion and Consideration of Potential Study Issue: High Quality Art at Affordable Low Income Housing

Trenton Hill provided background on the proposed study issue. Currently the Art in Private Development and Art in Public Places ordinance don't include residential development. Study issue will explore how viable the request is and if there is funding.

Chair Eskridge noted that funding could come from the developer, similar to Art in Private Development or Public Places ordinance that requires the developer to provide a percentage based on the evaluation or in-lieu fees.

Commissioner Filley proposed that the study issue center around high density housing, as opposed to just affordable housing. The trigger to include art could be based on the number of units or valuation of homes.

Commissioner Veith recommended that the Commission discuss with Housing

Commission.

Commissioner Kauffman recommend that staff reach out to neighboring cities. The City of San Francisco requires residential buildings to include artwork.

Commissioner Veith sponsored the study issue.

Commissioner Veith provided an update on the success of the Yarn in the Park Project and encourages the public to visit.
