The undersigned hereby agrees to the following conditions:

- Personnel from the Department of Public Safety will be used only in the capacity of Peace Officers and for no other purpose and shall at all times be subject to the supervision and control of the Department.
- The organization will be billed by the Department of Finance for services rendered by the Department of Public Safety at the rate of <u>\$184.00 per hour</u>, or fraction thereof per person with a minimum of two (2) hours and a <u>\$105.00 Administrative Fee per event</u>;
 - a. If a request for service is canceled at least 24 hours before the scheduled starting time, no fee shall be charged.
 - b. If a request for service is canceled less than 24 hours before the scheduled starting time, a sum equivalent to two hours of callback pay for each Officer scheduled to provide service shall be charged.
 - c. Each cancellation will be evaluated considering the then current circumstances.
- Two weeks advance notice is required prior to requested date of service. If service is requested with less than two weeks' notice, the request will be evaluated considering the then current circumstances.
 - a. An administrative fee, equal to the cost of setting up the short notice service assistance, shall be charged.
- 4. The Organization hereby agrees to indemnify, defend and hold harmless the City of Sunnyvale, City Council, Boards and Commissions, and individual members thereof, and all officers, agents, and employees, from and against all claims, damages, losses and expenses, including but not limited to attorney's fees, arising out of, resulting from or in any manner related to the service provided by the Department of Public Safety pursuant to this Agreement, regardless of whether or not such claim, damage, loss or expense is caused in part by a party indemnified hereunder, except that any injury to personnel of the Department of Public Safety incurred while performing such service shall be covered by the City's Compensation Insurance carrier.

I hereby certify that I have read the above conditions and do agree to conform to them and all applicable provisions of the laws of the City of Sunnyvale and the State of California pertaining to the assignment of Public Safety personnel for the purpose indicated in this agreement.
