Daniel Howard shared support for increasing the City Council compensation to broaden the candidate pool and be more inclusive of who can serve.

CHARTER SECTION 605 – CITY COUNCIL AND MAYOR COMPENSATION

Committee Member Davis provided a Subcommittee report on Charter Section 605 (City Council and Mayor Compensation).

Committee Members provided comments or questions related to City Council and

Mayor Compensation:

- Comment that an explanation about the American Community Survey is needed on Page 9.
- Comment that Sunnyvale was a charter law city in 1992, and that an explanation about Sunnyvale being similar to a general law city is needed on Page 9.
- Comment that having the total council compensation and population for neighboring cities to reference would be useful.
- Comments that including a red line of the proposed charter revisions to Section 605 on Page 12 would be useful.
- Comments that including inoperative language just because of its historical value may be confusing.
- Comment that the Subcommittee researched other cities' council compensation, and determined that their findings would not be included in the report due to the large volume of information and confusing data.

Public Hearing resumed at 6:05 p.m.

Zachary Kaufman suggested revisions to the background section on Page 9 of the draft report, shared support for including neighboring cities' council compensation, and spoke towards the reference on Page 11 of the draft report about the amount of material a councilmember reviews.

Steve Scandalis shared a presentation outlining suggested revisions to Pages 8, 9, 10, 11 and 12 of the draft report.

Public Hearing suspended at 6:11 p.m.

MOTION: Committee Member Vickrey moved and Committee Member Davis seconded the motion to approve the language on Page 12 that reads “The proposed revisions to Charter Section 605...” followed by Charter language with the following amendments:

1st paragraph of Charter Section

- Replace “2012” with “2027”;
- Replace “\$2,088.64” with “\$6,000”;
- Replace “\$2,784.86” with “\$9,000”; and
- Delete the last sentence.

2nd paragraph of Charter Section

- Replace "2013" with "2028";
- Revise "CPIU" to "CPI-U"; and
- Replace "2012" with "2027."

FRIENDLY AMENDMENT: Member Rubino offered a friendly amendment to revise the last sentence to reflect October 2027. The sentence was revised to read "The CPI-U index month and year shall be October 2027". Members Vickrey and Davis accepted the friendly amendment.

FRIENDLY AMENDMENT: Member Newswanger offered a friendly amendment to delete the word "month and year" and "October" from the last sentence. The sentence was revised to read "The CPI-U index shall be 2027." Members Vickrey and Davis accepted the friendly amendment.

CHARTER SECTION 606 – CITY COUNCIL VACANCIES

Member Vickrey provided Subcommittee revisions to Page 17, specifically the paragraph that reads “The CRC concludes that the average...”.

Public Hearing resumed at 6:45 p.m.

Zachary Kaufman suggested revisions to Pages 17 and 19 of the draft report.

Steve Scandalis shared a presentation outlining suggested revisions to Pages 8, 15, 16 and 19 of the draft report.

Public Hearing suspended at 6:51 p.m.

Committee Members provided comments or questions related to City Council Vacancies:

- Comment in support of revising the first paragraph of Page 19 to reflect “...a single Council district” instead of “a single Council seat.”
- Question related to the difference between a general municipal election and a statewide general election.
- Question whether the proposed language amendment to Charter Section 606(d) (vacancies) permits Sunnyvale to conduct an election during the next statewide general election that coincides with Sunnyvale’s scheduled general municipal election.
- Question whether it is acceptable to indicate that council appointees will hold office until the next general municipal election, November of an even-numbered year.

Staff provided comments or answers:

- Comment that statewide general elections occur every year and there could be a statewide general election on a date other than a Sunnyvale municipal election, particularly in odd-numbered years.
- Comment that the proposed language amendment to Charter Section 606(d) would require Sunnyvale to conduct an election during the next statewide general election that may be an odd year and not Sunnyvale's next general municipal election.
- Comment that Sunnyvale's Charter defines its general municipal election as November of even-numbered years.
- Comment that it is acceptable to indicate that council appointees will hold office until the next general municipal election to be held in November of an even-numbered year if that is the Committee's desire.

MOTION: Committee Member Pyne moved and Committee Member Oey seconded the motion to approve Section II.2 (City Council Vacancies), Section III.2 (City Council Vacancies) with suggested amendments incorporated into the draft report, Attachment 6, specifically Sections 605 and 606, and Attachments 7 and 8.

- Comment in support of the Subcommittee's recommendation of a settlement authority limit range of \$100,000 to \$150,000.

Steve Scandalis shared a presentation outlining suggested revisions to Pages 8 and 23 through 32.

Committee Members provided additional comments or questions:

- Revisions to the proposed language to Charter Section 1314(2) were communicated.

MOTION: Committee Member Oey moved and Committee Member Pyne seconded the motion to approve Section III.4 (City Manager Authority to Settle Claims), recommend a settlement authority limit range of \$100,000 to \$150,000, and suggested amendments be incorporated into the report.

FRIENDLY AMENDMENT: Committee Member Pyne offered a friendly amendment to approve Section II.4 (City Manager Authority to Settle Claims) with the addition of including a recommended settlement authority limit range of \$100,000 to \$150,000, and Attachment 6 specifically Section 1314. Committee Member Oey accepted the friendly amendment.

FRIENDLY AMENDMENT: Committee Member Oey offered a friendly amendment to recommend to City Council a settlement authority limit of up to \$150,000. Committee Member Pyne accepted the friendly amendment.
