

**DRAFT SECOND AMENDMENT TO SERVICE AGREEMENT
BETWEEN THE CITY OF SUNNYVALE AND
APPLEONE EMPLOYMENT SERVICES
FOR TEMPORARY PERSONNEL PLACEMENT SERVICES**

This Amendment to Services Agreement, dated _____, is by and between the CITY OF SUNNYVALE, a municipal corporation ("CITY") and APPLEONE EMPLOYMENT SERVICES, ("AGENCY").

WHEREAS, on June 27, 2012, CITY and AGENCY entered into a Services Agreement ("Agreement") whereby AGENCY would provide temporary personnel placement services; and

WHEREAS, on June 19, 2013, CITY executed a one-year option to renew the Agreement until June 30, 2014; and

WHEREAS, on December 16, 2013, CITY and AGENCY entered into an Amendment to the Agreement whereby total compensation was increased to \$95,000.00; and

WHEREAS, the parties now agree that a Second Amendment to said Agreement is advisable;

NOW, THEREFORE, THE PARTIES ENTER INTO THIS AMENDMENT TO SERVICE AGREEMENT:

3. Compensation

Replace the second sentence of this section with the following:

Total compensation payable under this agreement shall not exceed Two Hundred Thousand and no/100 dollars (\$200,000.00).

All other terms and conditions remain unchanged.
