2. Prioritize the Charter Review Committee Recommendations as follows:
  1. Public Works Contracting (Charter Section 1309): Allow public works project delivery methods permitted by state law;
  2. City Manager Authority to Settle Claims (Charter Section 1314): Amend the Charter to allow the City Manager to align the City Manager's claim settlement authority to the City Manager's contracting authority, which is updated at Council direction by ordinance;
  3. City Council Vacancies (Charter Section 606): Amend the Charter to require Council appointments to fill vacancies to last until the next general municipal election only (November of even-numbered years);
  4. City Council and Mayor Compensation (Charter Section 605): Increase monthly salaries to \$6,000 for councilmembers and \$9,000 for the mayor, and retain the existing annual increase based on Consumer Price Index (CPI); and
3. Direct Staff to poll on the four proposed amendments and return to Council in May 2026 with polling results;  
with the following modifications:
  - The polling on the Mayor and City Council salary increases should reflect the proposed numbers of the Charter Review Committee; and
  - The polling on the City Manager Settlement authority will be at the high-end of \$250,000 and additional numbers to be determined by the pollster (polling vendor).

Sharon spoke in support of strengthening street parking restrictions and banning Recreational Vehicles (RV's) from residential streets.

Chuck Fraleigh voiced their support for a street parking program and against adopting the proposed changes to parking requirements.

Steve Scandalis shared their concerns with how the proposed modernizing parking requirements ordinance will impact homeowners and commercial businesses who use street parking for extended periods.

Bryce Beagle communicated their support for prioritizing other vehicle safety concerns rather than modernizing parking requirements and restrictions.

Himanshu Sethi spoke to their concerns with the proposed parking requirements and support for a safe parking program.

Cortney Jansen voiced their concerns with the proposed parking requirements and restrictions.

Andrew G. shared their concerns with the proposed parking requirements support for a safe parking program.

Andrew Burks spoke in support of the proposed policy and offered their concerns over how the policy will be enforced.

Rose Gregorio shared their concerns with the proposed parking requirements and restrictions.

Angela Rauche voiced their concerns with the proposed parking requirements and provided statistics regarding the high demand for shelter beds for the unhoused in Santa Clara County.

- Direct staff to return after one year to determine if the evaluation and implementation of an oversized vehicle parking permit program and a potential prohibition on oversized vehicle parking near parks and schools is still needed;
- With the following modifications:
  - Return to Council with an ordinance with a ban on “vanlording”;
  - Return to Council with an ordinance with a ban on inoperable trailers on city streets; and
  - Reduce the movement distance required of vehicles to a 1,000 feet minimum distance to comply with the 72-hour parking limit.
