13. Briefly describe what you learned by attending a meeting of the City Council, board or commission. Describe what improvements you would suggest the City consider.

I think it is important that Sunnyvale residents have the opportunity to address the City Council on matters not on the City Council's agenda for the evening. However, I do think it is a problem when non-agenda items take up so much of the Council's time that agendized items are pushed back so late in the evening that members of the public may be deprived of their ability to sensibly comment on them, and Councilmembers are fatigued due to the hour. There are various ways to limit this but one neutral way could be to cap the total time for start-of-meeting oral communications to, say, half an hour and then re-open oral communications at the end of the agenda (before IGR reports) should anybody have been cut off by the cap.

I have been to many late night Council meetings. City Council meetings often begin the real substantive work late in the evening, after many residents have had to leave or log off. I wonder if there might be a way to structure meetings differently so that serious decisions get made when our elected officials and city residents are awake and alert. (I don't know if this is a charter issue, but it is certainly an effectiveness issue.)

I learned from 8 years of serving on the city's Sustainability Commission, that all parties have good intentions about making boards and commissions effective. However, I don't think the city makes effective use of the volunteer efforts of commissioners. (I don't think this is a charter issue. But some policy changes are certainly in order.)

I have been active over the past 20 years on the boards of several nonprofits and 2 public commissions.
