**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE AMENDING THE CLASSIFICATION PLAN TO ADD THREE NEW CLASSIFICATIONS AND CHANGE THE TITLE OF ONE CLASSIFICATION, AND RESOLUTION NO. 190-05, THE CITY'S SALARY RESOLUTION, TO UPDATE THE SCHEDULE OF PAY TO INCLUDE THOSE CLASSIFICATIONS**

WHEREAS, at the request of the Office of the City Manager, the Human Resources staff has proposed an amendment to the Classification Plan of the Civil Service of the City of Sunnyvale to change the title of "Director of Information Technology" to "Chief Information Officer" to better describe the position and the duties performed; and

WHEREAS, at the request of the Environmental Services Department, the Human Resources staff has proposed an amendment to the Classification Plan of the Civil Service of the City of Sunnyvale to add the following newly-established job classifications of "Principal Water Pollution Control Operator," "Cross Connection Control Specialist" and "Water Pollution Control Plant Mechanic in Training"; and

WHEREAS, the City Council having considered such proposals and recommendations desire to approve the amendment to the Classification Plan of the Civil Service.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

1. The City Council hereby approves an amendment to the Classification Plan of the Civil Service as follows:
  - a. Change the title of Director of Information Technology to Chief Information Officer (0190);
  - b. Create the classification of Principal Water Pollution Control Operator (5752) with a pay range of \$41.7324 (Min. range/ Step 1); \$43.8193 (Step 2); \$46.0103 (Step 3); \$48.3108 (Step 4); \$50.7263 (Step 5); \$53.2626 (Max. range/ Step 6) hourly;
  - c. Create the classification of Cross Connection Control Specialist (5753) with a pay range of \$31.5384 (Min. range/ Step 1); \$33.1152 (Step 2); \$34.7709 (Step 3); \$36.5096 (Step 4); \$38.3352 (Step 5); \$40.2519 (Max. range/ Step 6) hourly;
  - d. Create the classification of Water Pollution Control Plant Mechanic in Training (5399) with a pay range of \$28.9783 (Min. range/ Step 1); \$30.4272 (Step 2); \$31.9486 (Step 3); \$33.5460 (Step 4); \$35.2233 (Step 5); \$36.9845 (Max. range/ Step 6) hourly.

2. Except as herein modified, the Classification Plan, Resolution No. 143-77, as amended, shall remain in full force and effect.
3. Resolution No. 190-05 is hereby amended by adding the classifications and pay rates set forth in Exhibit "A," to the schedule of pay (salary table), attached and incorporated by reference, to implement the changes described in this resolution.
4. The Salary Resolution amendments and pay rates noted above shall be effective the pay period including March 12, 2017.
