Planning Commission

Sunnyvale has limited vacant land for new development. This could increase pressure for redevelopment of existing developed areas. How can Planning respond to this situation?

Planning can respond to limited vacant land by taking a strategic, sustainable, and inclusive approach to redevelopment. This means focusing on smart growth - encouraging mixed-use developments, higher-density housing near transit, and reimagining underutilized spaces in a way that aligns with the city's General Plan and community needs.

Redevelopment should prioritize walkability, affordable housing, and livable neighborhoods while preserving community character. It's also important to engage the public early and often, especially communities who are most impacted by redevelopment, to ensure equity and transparency.

As a tech leader and small business owner, I recognize the need to support growth that accommodates our workforce and keeps Sunnyvale competitive, while also protecting what makes it a great place to live. Thoughtful zoning updates, adaptive reuse of existing buildings, and collaboration between city departments can help meet our future needs without sacrificing quality of life.

Planning Commissioners are often asked to consider social, economic and environmental issues when reviewing proposals. How do we achieve a balanced community?

Achieving a balanced community means considering social equity, economic opportunity, and environmental sustainability in every planning decision. As someone deeply involved in the growing Nepali community in Sunnyvale, I've seen firsthand how access to affordable housing can transform lives.

One example that stands out is a Nepali family I know who was able to stay in Sunnyvale and raise their children here thanks to access to below-market-rate (BMR) housing. The parents both worked long hours to support their family, and without BMR housing, they likely would have been priced out of the city. Instead, they were able to build stability, send their kids to local schools, and become active, contributing members of the community. Their children are now thriving - one is pursuing college locally and the other is already giving back through volunteer work.

Stories like this are a reminder that balanced planning isn't just about buildings - it's about people. Supporting diverse housing options, accessible transit, and vibrant public spaces ensures that all members of the community, including immigrants and working families, have a chance to succeed and feel a sense of belonging.

What do you see as the greatest land use challenges facing the City? How do you propose addressing them?

One of the greatest land use challenges facing Sunnyvale is the limited availability of vacant land, combined with the growing demand for housing, commercial spaces, and infrastructure. With limited land left for new development, the city must focus on redeveloping underutilized areas, such as aging commercial properties and industrial zones, to accommodate future growth without compromising the quality of life for existing residents.

Another challenge is ensuring that this redevelopment supports affordable housing while maintaining the character and diversity of neighborhoods. As Sunnyvale evolves, it's important to avoid displacing vulnerable communities, particularly immigrant families and small business owners who may already be struggling with rising rents.

To address these challenges, I propose focusing on smart infill development - redeveloping existing sites with a mix of residential, commercial, and community spaces. This would help maximize land use while reducing sprawl. Additionally, transit-oriented development should be prioritized, particularly around key transit hubs, to support sustainable growth and reduce traffic congestion.

We also need to ensure that affordable housing remains a central focus in these redevelopment plans. This could include a stronger emphasis on the below-market-rate housing programs and working with developers to include affordable units in new projects. Finally, community engagement is essential; actively involving residents in the planning process ensures that redevelopment meets the needs of all groups - particularly those who have historically been underrepresented in decision-making.




