## Staff Report

### **SuperBowl is at Levi Stadium 08-FEB-2026 - security and transportation update**

- VTA Light Rail will **NOT** operate past Lick Mill Westbound and Great America East Bound lines.
- ***Bus Bridge will operate to assist affected passengers from Bayside to Old Ironside stations to bypass the stoppage.***
- Comprehensive EAP (event action plan) with multiple agencies and municipalities regarding security, access, safety, etc. and emphasis on human trafficking prevention.
- **San Thomas Aquino Creek Trail** closures and **trail detour closures** - trail will be closed for a week, detour route may be closed for longer (!) up to a month due to security measures.
- Requested further information on the effect on Tasman/Lawrence Expy intersection and residents in the local area.
- **Next Gen Clipper cards** - full deployment open payment acceptance on all transit operators, online applications for senior and student cards, 10-DEC-2025 launch.

### **2016 Measure B Bike Ped Call for Project Grant Applications are due by 4pm Monday February 9th, 2026.**

#### **Complete Streets Policy Update:**

Policy updates NACTO principles for all ages and ability designs.

Alignment with MTC 2022 complete streets policies.

Concerns expressed over current language regarding design standards and prioritization of projects which improve multi-modal use.

Suggest people read most critically Section B - which specify exceptions to the policies.

**VTA BPAC deferred voting on changes as there was a request to form a subcommittee to review and incorporate the feedback received.**

**I have been selected for the subcommittee and will give an update in a future report.**

**Upshot was that the BPAC members were not satisfied with the current edits, and that the language was considered 'weak' in many areas, and since the document was overdue for revision and that it would be 10 years before another revision would be considered, if it was approved.
