What do you think are major equity challenges facing the Sunnyvale community?

Like most of the country wealth and housing security inequality are major challenges we're facing. Additionally, the attacks from the federal government on funding for diversity and equity initiatives is going to continue to cause additional stress on already marginalized communities and Sunnyvale is going to have to do even more to ensure the safety and security of those folks. We already do a great job of celebrating diversity in our community, but we're going to have to take more defensive measures to keep the great progress we've made from being rolled back.

Describe your experience working Growing up in Michigan as a child of middle eastern immigrants I saw first hand how racism and othering people can impact communities. Both of my parents were public school administrators so I was exposed to service at a very young age, especially with underserved families in rural areas. I've kept that sense of service throughout my life. At Digital Game Museum we established programs to work with schools to bring in kids from underserved communities to learn about accessioning (checking in artifacts) and the importance of archiving history. At Guidewire I served on the ONYX employee resource group and ran the media club where I worked with a group of other employees to select movies featuring powerful black characters and stories and then lead guided discussions about the themes of the films. My current job at Center for Internet Security focuses on providing cybersecurity services to underserved communities though developing tools and mechanisms to bridge the gap between resources and historical marginalization to ensure that those folks have access to high quality tools to help secure their communities. I also am active in the IDEA Alliance, our diversity and inclusion group. I host our media group which focuses on films or readings on diversity topics ranging from LGBTQIA+ topics to Land Back and native rights initiatives. I've worked to bring in speakers on these topics to present their real life experience to our team and drive insightful conversations that highlight the importance of diversity and elevating marginalized
