Guaranteed Basic Income (GBI)

Universal Basic Income (UBI) provides all individuals a regular unconditional payment

Guaranteed Basic Income (GBI) refers to a similar concept for a targeted population

We use the term “**GBI**” in these materials

GBI pilots have proven results (1 of 2)

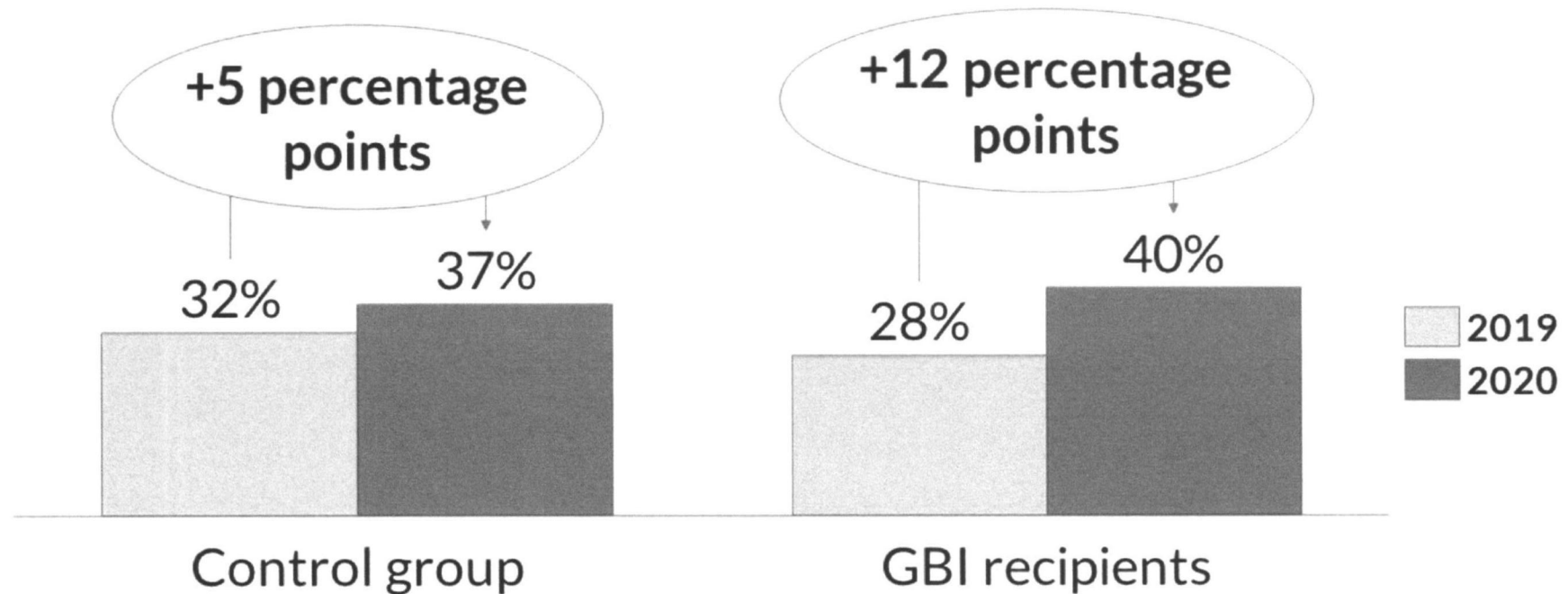
- **Higher probability of finding full-time employment²**
- **Increased housing stability³**
- **Improved mental health**, with fewer signs of depression and anxiety among participants
- **Reduction in household income volatility²**
- **Increased opportunity for self-determination**, agency, goal-setting and risk-taking ²

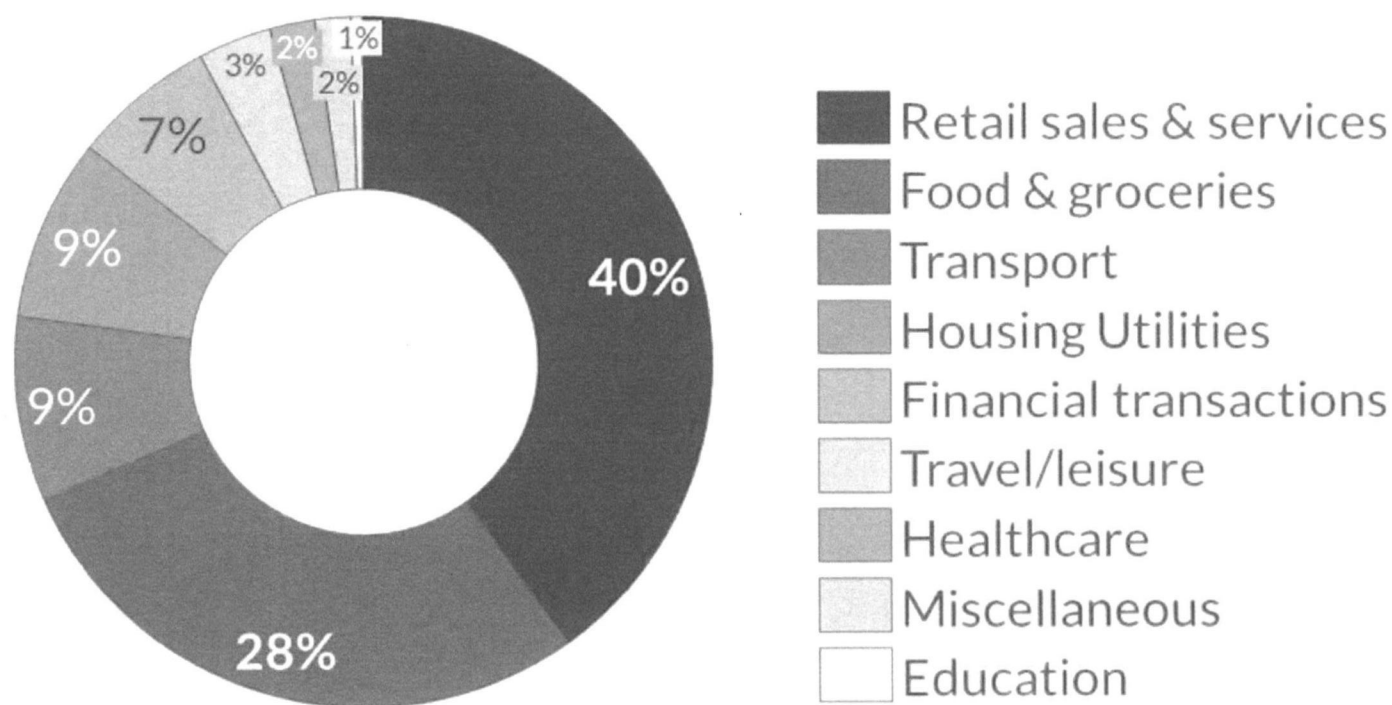

What is Sunnyvale already doing similar to GBI? (1 of 2)

1. TBRA: Tenant Based Rental Assistance

- **Objective:**

- *Time-limited rental assistance, maximum 2 years – coupled with case-management/employment services*
- *No HH pays more than 30% of income on housing*

- **Funding:**

- *HOME Investment Partnerships (HUD)*
- *Up to \$1M per year in rental assistance*
- *\$350k per year in local funds for case management/ administration*

- **Capacity:**

- *40 Households (recently increased from 20)*
- *Administered by Sunnyvale Community Services*

What is Sunnyvale already doing similar to GBI? (2 of 2)

2. Senior Rental Assistance program

- **Objective:**

- Support severely rent-burdened *senior households*
- Starting Spring 2024

- **Funding:**

- Permanent Local Housing Allocation Program (**PLHA**)

- **Capacity:**

- Assist 40 households @ \$1,000/month

- **Funding Available \$1M** (for next 2 years)

Step Ladder

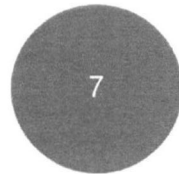
Be catalytic and provide opportunities for self-improvement and upward mobility

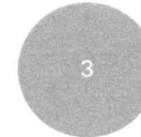
- Education grants

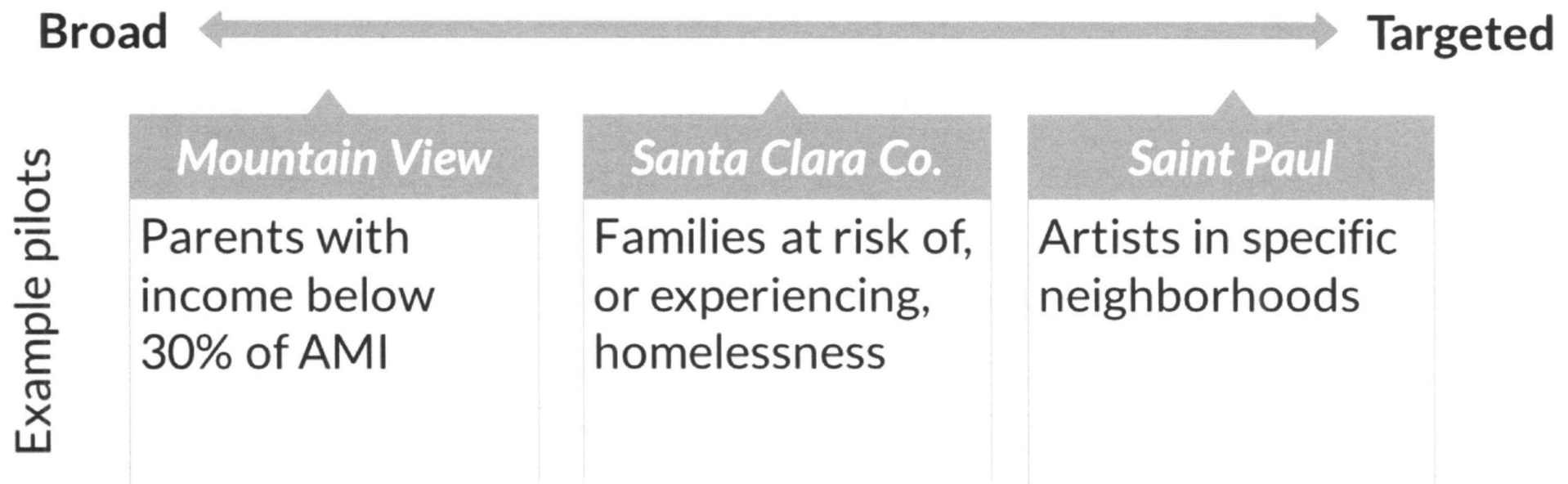

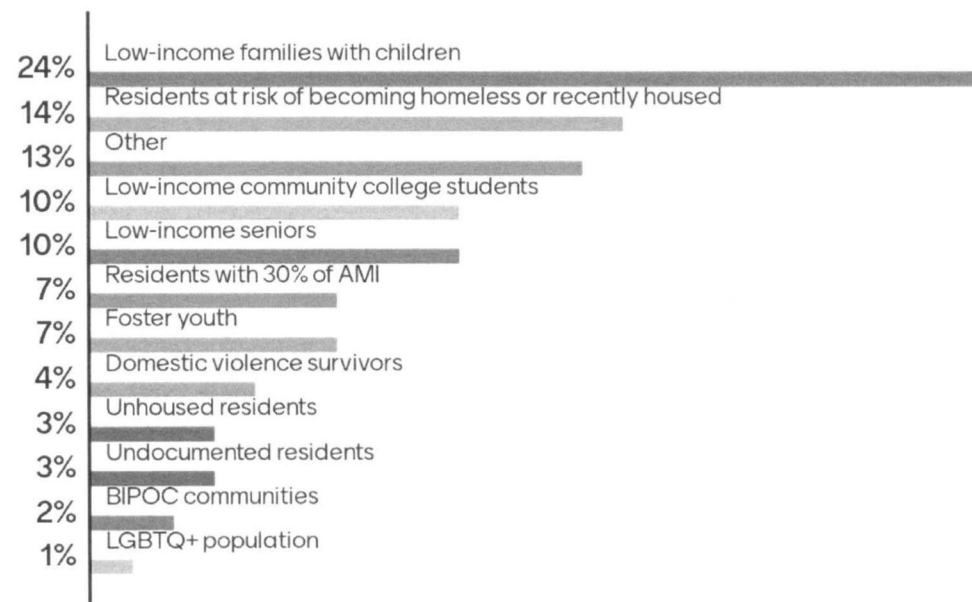

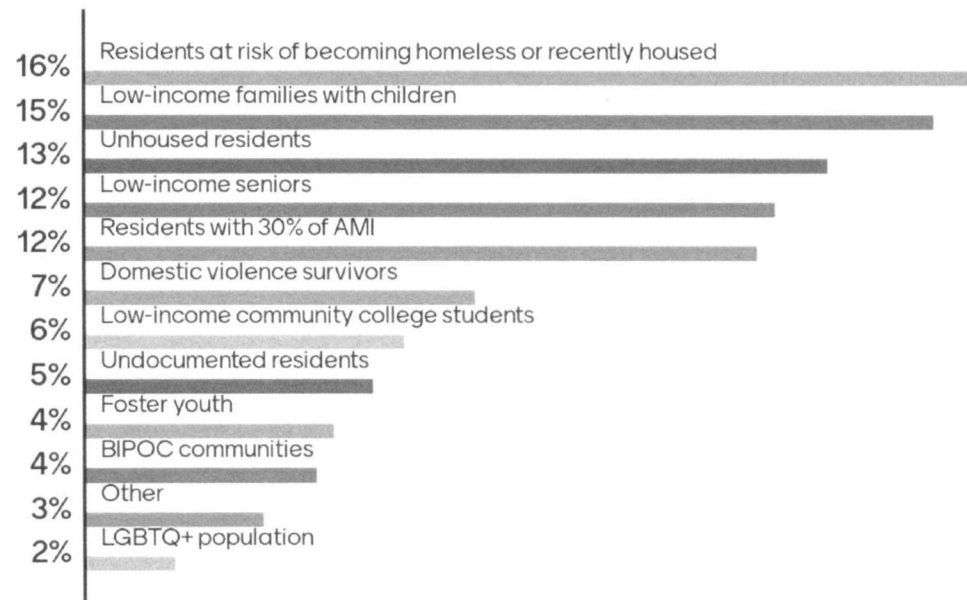

What are the typical characteristics?

- Participants: **100 – 325**
- Frequency: **Monthly or Hybrid (lump sum + monthly)**
- Amount: **\$500 - \$1,000**
- Duration: **1-2 Years**

Note: The ranges for number of participants and duration of pilot reflect the 20th to 80th percentile of the pilots reviewed. The frequency of payments, administration costs, and range for the amount of support provided is based on expert interviews and research.

Imagine you have an annual \$1M budget... What program characteristics would best meet the needs of our community?

Number of participants

I have no idea

I would rely on your research as to what would be most effective. At some point, the dollar amount and period of time would become meaningless (\$1 for 1x), and I trust you to know best.

That's discouraging—can we have more money? If not 100 people, monthly \$500, 1 year

Maximize amount for 1 year, 50%/50% hybrid model, 150-200 people

Have more than one benefit package: not only \$500 per month for 2 years, not same amount each recipient, etc. Stress being effective for each recipient, rather than maximizing number of benefits. ...

Imagine you have an annual \$1M budget... What program characteristics would best meet the needs of our community?

All of the above.

Longer duration and consistent funding

Program should be 2 years long. I like the idea of offering people a choice of lump sum or monthly payments.

I would grant monthly payments up to two years and have atleast 100 to 200 residents participate. If the program can have more people to participate that would be great.

1 Maximize families with children under 5, 2 Monthly3 \$5004 Until the money runs out

5 years, hybrid system--30% lump, balance monthly, as many participants as possible with the broadest spread of situations.

At least \$500/month, choice of hybrid lumpy or fixed stipends, 2 years, as many ppl as possible.

100 participants;18 month \$500/month

Imagine you have an annual \$1M budget... What program characteristics would best meet the needs of our community?

Number of participants

I would select a balance among these, with minimums (e.g. at least \$500/month, helping as many as possible, for 18-24 months). Test out hybrid too, if possible, for a few people.

maybe 250-300 people? monthly or bi-monthly, max support \$1k, 2-4 years. how can we help people make the best immediate relief/impact for their life in the shortest time possible so they can grow?

Do a mix of 60% families and 40% individuals (or 70/30). Should focus on people struggling financially the most.

All households below median income
Every month \$1,000 a month
Until money runs out

100 participants for pilot. 1/2 to families in need. 1/2 to others (seniors, foster youth, etc.).

I would give \$1000 instead of \$500 since this area is very expensive. I would prioritize people with children with income below 30% of AMI but also include people without children who fit this criteri

75 participants \$1000 monthly for 1 year. Then reevaluate based on outcome measures

\$500 wont help much, GBi to let people have relief but also get a better start for their future via saving and investing in themselves. mental health, quality of life, savings

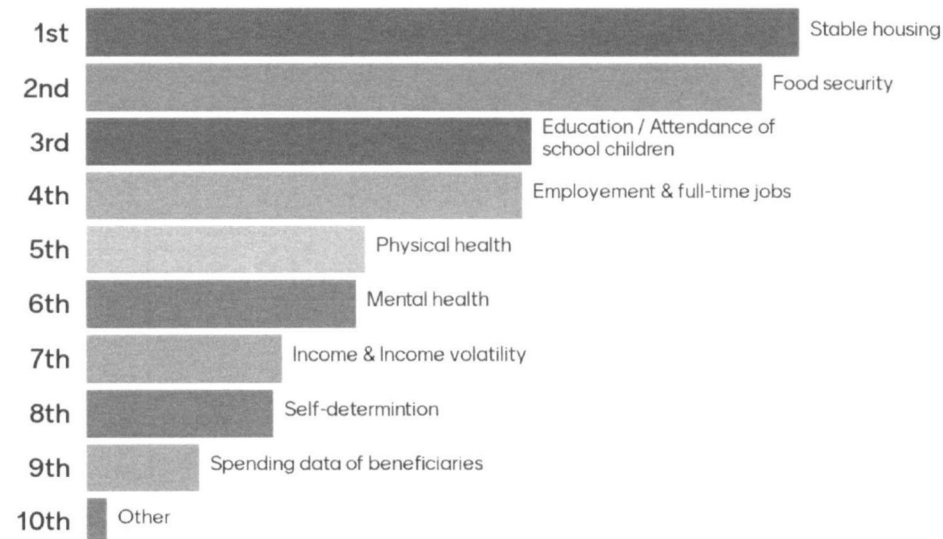

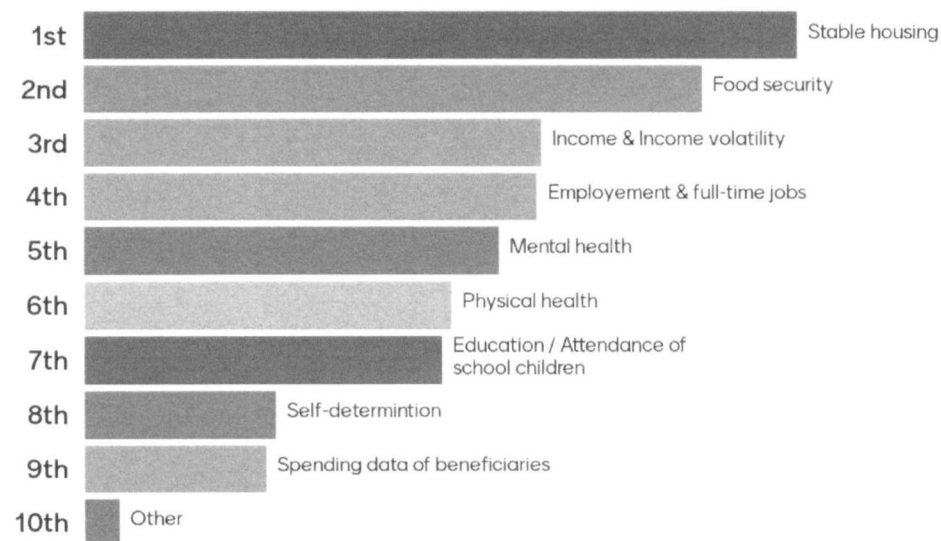
Important considerations include:

- Defining the **rigor of monitoring and evaluation** (e.g., randomized controlled trials vs tracking basic indicators through existing systems)
- **Addressing concerns** regarding GBI (e.g., disbursement methods) and **mitigating risks** (e.g., benefits cliff)

and admin support.

Targeting is not free. Keep it as
simple as possible. Do not waste
funding on tracking or
investigating people who need
help. Give money to everyone who
needs help.

Sooner implementation is better
than slower...data driven by the
least-worst existing mechanisms.
Subjective data are also important
from participants on a bi-annual
basis.

Curious of the application process
or the criteria and how soon this
can be implemented. Inflation and
job stability have increased faster
than relief support.

This city should lead on this. Why
are we so slow to join what other
cities have done? How can we add
to what other cities have learned?

Do you have any comments or concerns regarding the execution of the pilot?

Add a feminist perspective, like Next Door Solutions, who support women and families who suffer financial violence as well

My preference would be UBI

Have to do enough tracking/reporting to defend the program. (Answer the critics.)

Why not have an employee tax to fund

Where are we lacking in terms of existing support, who are we not working on supporting yet? How can we help others in need now.

How can we identify longterm funding to broaden beyond a pilot?

I do think that we can look at some unique characteristics of Sunnyvale/Silicon Valley and families with children for some specific outcomes/measures, and include case management/ financial literacy.

How can we help people who are struggling but dont have options for support? There is government assistance for very low income but what about people who have some income but not enough to thrive?

Do you have any comments or concerns regarding the execution of the pilot?

Will the high cost of living in Sunnyvale skew the results and efficacy of a \$1000/month payout. In comparison to less costly areas that have had pilot UBI/GBI programs

Yes, contributing to a greater UBI would be most productive for everyone. Agree with Andrew Yang

How will the City fund the pilot?

Potential sources of co-funding include:

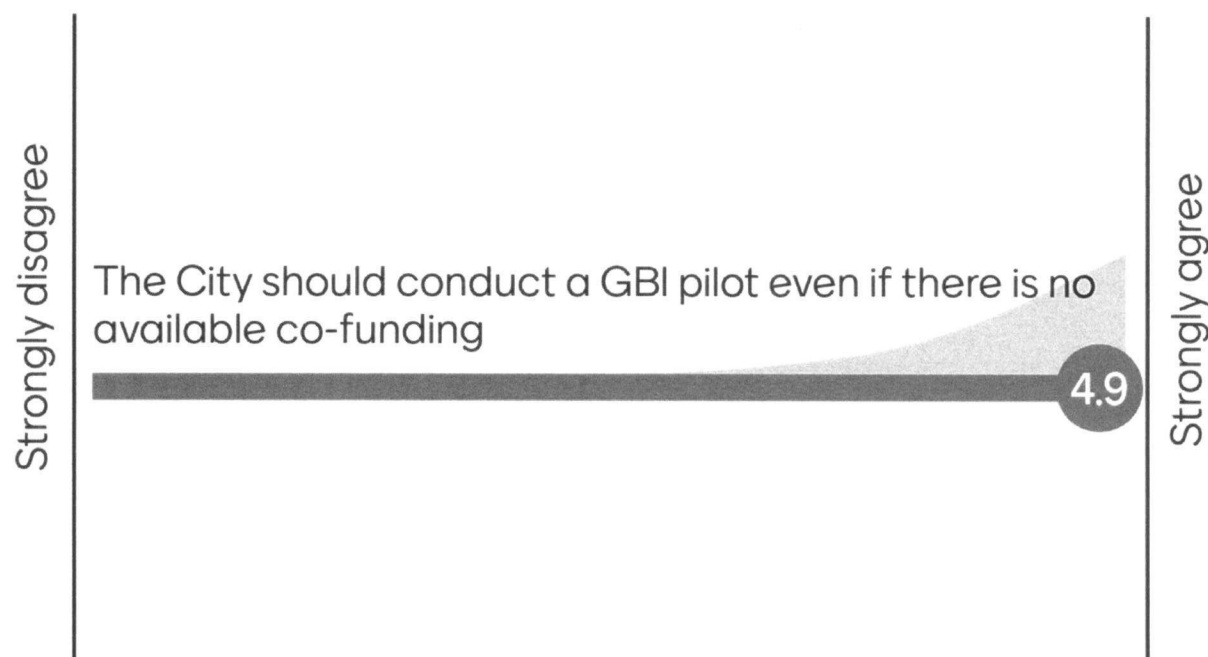
- May be possible

Philanthropic funders

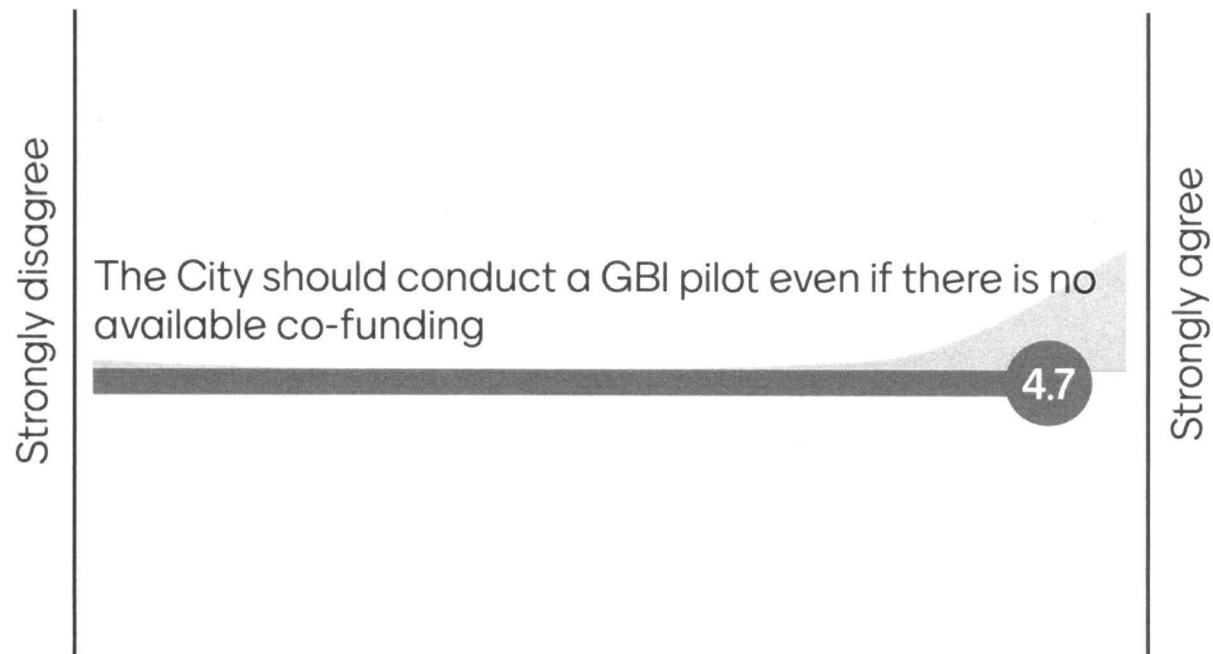
- Growing pilot fatigue
