Purpose of Ordinance Amendments

- Modernize outdated procurement rules
- Streamline processes to reduce administrative burden
- Facilitate the transition to PlanetBids (e-procurement)
- Align thresholds with peer cities & recognized best practices

Why Change is Needed

- Old matrix included too many thresholds and was overly restrictive
- Required 3 quotes even at low dollar levels (\$15k-\$25K)
- Generated 1,600+ additional POs annually, slowing project and service delivery
- Manual bid openings were paper-intensive and prone to errors

Goods & Services Thresholds (Old vs. New)

Old (2022)

- \$15k-\$25k 3 Quotes
 Required
- \$25k-\$100k Written IRFP,IRFQ,ERF

New (2025)

- No minimum up to \$50k
- \$50k-\$100k 3 Quotes
 Required

Still Required

- Over \$100k Formal bids
- Over \$250k Council approval

E-Procurement Transitions (PlanetBids)

Old Process

- In-person, paper-based bid openings
- Risk of misplaced or late bids
- Manual tabulation and limited visibility
- Paper-intensive and inefficient

New Process (PlanetBids)

- Secure, time-stamped electronic submissions
- Automatic public opening deadline
- Vendors see results online in real time
- Paperless, transparent, and cost-effective

Delegated Authority Updates

- Policy Flexibility Director of Finance authorized to interpret and adopt policies
- Delegated Authority: City Manager with Finance/Public Works may delegate procurement authority
- Increases responsiveness and reduces bottlenecks

Key Benefits & Fiscal Impact

Key Benefits

- **Efficiency:** Up to 1,600 fewer POs annually
- **Speed:** Faster project delivery
- Fairness & Transparency: Equal vendor access via Planet Bids
- Cost Effectiveness: Less staff time; reduced admin costs
- Modernization: Aligns with peer cities & industry standards
- Sustainability: Reduce paper processes
- No direct final cost

Fiscal Impact

- Possible nominal price increases
- Offset by:
 - Staff time savings
 - Reduced administrative overhead
 - Faster delivery of services/projects

Recommendations and Next Steps

Introduce Ordinance Amending Chapters 2.08 & 2.09

- Bid Thresholds
- PlanetBids e-procurement system
- Delegated authority

- September 9, 2025: First Reading
- September 30, 2025: Second Reading
- October 30, 2025: Ordinance effective
- Rollout: Updated procurement policies and procedures implemented immediately following adoption
