Briefly describe what you learned I've learned that the City Council diligently observes the Brown Act and transparency requirements by posting agendas and discussion questions in advance, allowing the community to engage. Such disruptions stifle meaningful dialogue, drain City resources, and-most importantly-undermine the psychological safety of attendees from marginalized communities. I'd like to think about how we could improve the safety and inclusivity of these meetings for all participants, and amplify the voices of Sunnyvale residents in particular.

What motivated you to apply for this board or commission?

Yet I've also seen the anxiety that rises when hate crimes spike in the wider Bay Area or when online harassment spills into civic spaces.

Serving on this commission would let me translate those lived experiences into action: advocating for well-lit, secure gathering places; encouraging culturally inclusive programming in our parks and libraries; and ensuring that public-safety initiatives explicitly protect minority communities. My background in product management has trained me to listen closely, build consensus, and turn community feedback into concrete, measurable outcomes - skills I'm eager to apply on behalf of all Sunnyvale residents.

What do you think are major equity challenges facing the Sunnyvale community?

One of Sunnyvale's most urgent equity challenges is the sharp rise in antisemitism and other forms of hate. Over the past year our City Council meetings, school events, and even community festivals have been interrupted by antisemitic rhetoric or imagery, forcing Jewish residents, including school-age kids, to weigh personal safety before speaking up or attending civic gatherings. In 2024 alone, Northern California logged nearly 500 antisemitic incidents, and several of those occurred in or near Sunnyvale.

But antisemitism does not stand alone. Asian American neighbors remain targets of post-pandemic bias; Muslim and Sikh residents have reported Islamophobic harassment; and LGBTQ+ youth continue to face bullying. Layered on top of identity-based hate are structural inequities: soaring housing costs that push lower-income families and seniors to the margins; language barriers that limit civic participation for the 45 percent of households that speak a language other than English at home; and uneven access to safe, affordable transportation and high-speed internet, which widens educational and economic gaps.

Addressing equity in Sunnyvale therefore means two things at once: (1) taking a hard line against hate - through stronger meeting-civility rules, better incident reporting, and visible solidarity campaigns - and (2) tackling the systemic barriers that keep many residents from feeling they fully belong or can thrive here. By viewing antisemitism as a 'canary in the coalmine' rather than an isolated problem, we can craft policies that make every community safer and more included.

Describe your experience working Early in my career I volunteered with programs that introduced girls and young women to computing and engineering: this includes meeting with girls in middle school and high school and speaking in panels, sharing my experience as an engineer. Those sessions helped several participants choose STEM majors, proof that early exposure really does widen the talent pipeline.

> Inside Google today, I mentor product managers from diverse and under-represented backgrounds. We meet monthly and discuss job challenges in a safe environment.

> I also stay deeply involved in Sunnyvale's Jewish community, a group that has historically faced discrimination and, more recently, a troubling spike in antisemitic incidents. I participate in the Bay Area Jewish Coalition to help organize interfaith events, represent the needs of the Jewish community, and combat antisemitism. I also volunteer at my kids' school, teaching Project Cornerstone, which gives kids the social and emotional tools they need to be upstanding members of society. I also organize Hanukkah celebrations every year in my kids' classrooms! Dreidels and doughnuts are always a big hit:)
