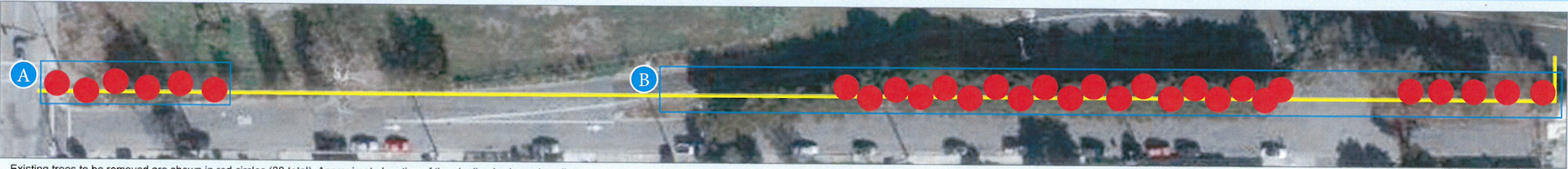
## E California Avenue Restoration Plan - Sunnyvale, CA

Location: E California Avenue, Sunnyvale, CA (RW\_V\_8484\_15)

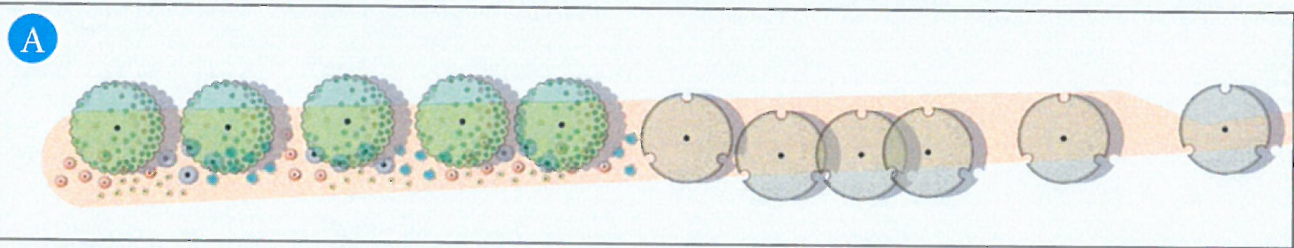

Existing trees to be removed are shown in red circles (30 total). Approximate location of the pipeline is shown in yellow.

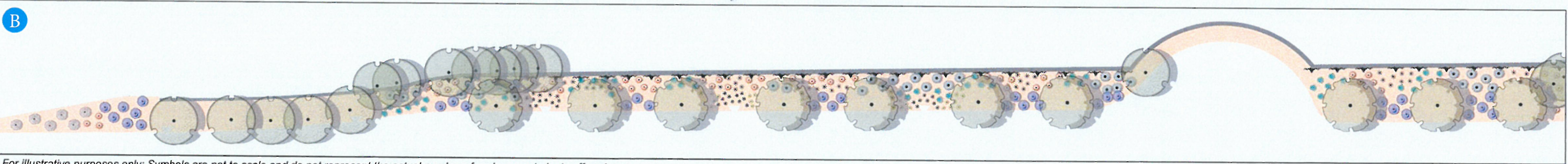
### Conceptual Restoration Plan
