It's also crucial to preserve existing affordable units and support programs that stabilize at-risk households. To better serve unhoused residents, expanding access to temporary shelter, mental health services, and pathways to permanent supportive housing is key. Collaborating with nonprofit partners, faith-based organizations, and county resources can build a stronger safety net and a more compassionate approach to addressing homelessness.

This includes supporting mixed-use developments, infill projects, and transit-oriented design to reduce sprawl and increase accessibility. Community engagement will be essential to ensure that redevelopment addresses real needs-such as affordable housing, green space, and economic opportunity-while respecting the scale and identity of neighborhoods. Incentivizing adaptive reuse and sustainable building practices can also help meet demand without compromising environmental goals.
