Sustainability is a new and emerging concern in many communities. What do you think are the primary sustainability policy issues this commission will be addressing over the next few years?

In the next few years, the commission should focus on helping residents and businesses switch from gas to electric appliances, since natural gas remains a major source of emissions in Sunnyvale. This includes advancing policies and ordinances that speed up electrification while ensuring upgrades are affordable and accessible. In transportation, it's important to expand EV adoption and ensure public charging stations are available across all neighborhoods. Waste reduction also deserves attention-particularly through programs that redirect surplus food to local centers and underserved communities. Finally, we need to prepare for climate impacts like extreme heat, wildfire smoke, and flooding by updating emergency plans and ensuring residents are informed and supported.

While Sunnyvale has made progress, implementation timelines can be slow. Electrification policies need stronger enforcement and clearer support for renters and small businesses. Public charging infrastructure, though expanding, still lags behind rising EV demand, especially in multi-family areas. Waste diversion efforts would benefit from more visible public outreach and easier participation. Emergency preparedness programs could do more to engage residents, such as by offering sustainability-focused emergency kits with solar lamps and reusable masks-simple tools that also raise awareness and build community resilience.
