What do you think are major equity challenges facing the Sunnyvale community?

Sunnyvale is one of the most diverse cities in the Bay Area, but that doesn't mean everyone experiences that diversity equally. The biggest equity challenge right now is housing. Santa Clara County's 2025 Point-in-Time Count reported over 10,700 people experiencing homelessness, and that's not just a statistic, it's families, students, and neighbors. Even for those who aren't unhoused, rent and cost of living are rising so fast that many longtime residents are being displaced. Stable housing directly impacts education, safety, and access to opportunity, so tackling that gap matters for everyone.

Another major challenge is language and access. Almost half of Sunnyvale's residents speak a language other than English, yet a lot of city communication, from community programs to public feedback, still leans heavily on English-only systems. It's not intentional exclusion, but it creates real barriers to participation. Translating resources and making outreach more multilingual would help more people feel part of civic life.

Lastly, there's the challenge of belonging and representation, especially for marginalized communities and youth. Sunnyvale's Human Relations Commission has already discussed issues like antisemitism and bias incidents, which shows progress, but the work can't stop there. We need to make sure the city feels safe and connected for everyone across faiths, backgrounds, and ages. I think one of the most powerful steps would be increasing youth involvement in civic conversations, since we experience these equity issues firsthand and can help design solutions that last.

with historically marginalized communities. How have your actions benefited these communities?

Describe your experience working Most of my work centers on making opportunities accessible for people who are usually left out, especially students and underrepresented groups. With my robotics team, FTC Team Taro #13218, I help lead free STEM workshops for younger students, including those from families without access to coding tools or expensive equipment. We plan sessions at schools across the district, design beginner-friendly activities, and make sure no one ever has to pay to participate. It's simple changes like that that help more students, especially first-generation and low-income ones, feel confident getting into STEM.

> Outside of that roles, I've worked on hackathons and youth programs where I've pushed for inclusive practices like clear codes of conduct, prizes in the form of scholarships, and beginner tracks all to make sure nobody feels like they don't belong in tech or community events. Across everything I do, my goal is to listen first, identify what's keeping people out, and remove those barriers. I'd bring that same mindset to the Human Relations Commission, one that focuses on empathy, access, and turning good intentions into measurable change.
