- Staff will return to Council immediately if there is suspicion of unauthorized external, including federal, access;
- Direct staff to engage/participate in the County of Santa Clara County's ALPR initiative; and
- ITD will actively monitor for vulnerabilities in the Flock Safety system.

FRIENDLY AMENDMENT: Councilmember Cisneros offered a friendly amendment to direct staff to immediately disable the system if there is unauthorized access by the federal government. Vice Mayor Mehlinger accepted the friendly amendment.

FRIENDLY RESTATED AMENDMENT: Vice Mayor Mehlinger restated the friendly amendment: Direct staff is to disable the system and return to Council immediately if there is suspicion of unauthorized external, including federal, access.

- Direct staff to engage/participate in the County of Santa Clara County's ALPR initiative;
- ITD will actively monitor for vulnerabilities in the Flock Safety system; and
- Direct staff is to disable the system and return to Council immediately if there is suspicion of unauthorized external, including federal, access.
