A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE AMENDING RESOLUTION NO. 1151-22, THE CITY'S SALARY RESOLUTION, TO UPDATE PAY RATES FOR CASUAL/TEMPORARY CLASSIFICATIONS TO REFLECT THE JANUARY 1, 2025 SUNNYVALE MINIMUM WAGE, INCREASE THE COUNCILMEMBER AND MAYOR STIPEND AMOUNTS PURSUANT TO CITY CHARTER SECTION 605, AND MOVE THE 3.5% LEAD WORKER/SUPERVISOR PREMIUM PAY FOR ATTORNEYS INTO BASE SALARY

WHEREAS, as of January 1, 2025, the City of Sunnyvale minimum wage will increase from \$18.55 to \$19.00 per hour; and

WHEREAS, City Charter section 605 provides for annual cost of living increases for Councilmembers and the Mayor based on the Consumer Price Index; and

WHEREAS, staff is recommending moving the 3.5% lead worker/supervisor premium pay into base salary for employees in Category K (Attorneys) to address departmental needs; and

WHEREAS, the City Council of the City of Sunnyvale desires to amend the City's Salary Resolution and Schedule of Pay to reflect these changes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

- 1. Resolution No. 1151-22 is hereby amended by:
 - (a) Amending the text of Section 4.305 the City's Salary Resolution as set forth in Exhibit A (Salary Resolution) to reflect changes to Category K positions to read as follows (changes in underline):

4.305 Lead Worker/Supervisor Premium Pay

Effective June 29, 2008, employees in Category D and K who routinely and consistently lead or supervise employees in the subordinate classifications or job functions described below shall be paid a 3.5% Lead Worker/Supervisor Premium on all paid hours.

Applicable subordinate classifications or job functions include:

(a) Sensitive positions requiring trust and discretion as provided in Section 4.300; or

(b) Classifications that prepare City Council agenda and minutes and perform the duties of the City Clerk in their absence; or

(c) Job functions that support sensitive projects directly assigned by the City Manager. <u>Effective December 22, 2024, the 3.5% premium will be removed</u> from Category K positions, and the applicable salary ranges and pay rates for those positions will be increased by 3.5%.

- (b) Amending the pay rates set forth in Exhibit A (Salary Schedule). Exhibit A is attached and incorporated by reference, and the changes shall be effective on the dates set forth in Exhibit A.
- 2. All other provisions of Resolution No. 1151-22 shall remain in full force and effect.
