Our main library's infrastructure is aging, with ongoing maintenance issues. The 2024 library bond measure, intended to solve those issues, failed. What solutions do you suggest?

While the bond failed, it only missed the mark by a little. More than a majority voted for a new main branch, so the support is there. I would like to hear more discussion of funding sources. If not a bond measure, is there another set of financial tools available? What are other cities doing to build and support libraries? I would look to the success stories in other Bay Area cities to find a route for the library.
