Like many Santa Clara County cities, Sunnyvale is faced with problems stemming from traffic congestion and air pollution. Suggest ways the City can improve facilities for bicyclists and pedestrians. Also, how might the City improve education and safety programs for motorists, bicyclists and pedestrians?

To improve facilities for bicyclists and pedestrians, the City could invest in more protected bike lanes, expand bike-sharing programs, and ensure safe, well-lit pedestrian paths-especially near schools, parks, and libraries. Personally, my 3-year-old son rides his pedal bike with his dad every weekend to visit our local park, library, and city events, and I envision a future where kids like him can ride safely and confidently around Sunnyvale. Expanding safe biking infrastructure would make this vision a reality for future generations of young riders.

Incentives, like discounts for bike rentals, bike-to-work programs, or rewards for using sustainable transportation, could also encourage more residents to choose biking over driving. These programs would make biking more accessible and appealing, especially for families and commuters.

Their programs-such as rent and utility help, food distributions, and school supplies-are highly rated and essential in preventing homelessness and stabilizing families.

> As a regular donor to SCS, I've seen firsthand the positive impact they have on our community. While SCS is effective, continued expansion and collaboration with local partners would help meet the growing demand for services. Strengthening these programs will further support Sunnyvale's most vulnerable populations.

Share your thoughts on how the City might better improve housing affordability, prevent displacement and serve our unhoused residents.

To improve housing affordability, the City could prioritize the development of more affordable housing units, including increasing the number of Below Market Rate (BMR) units and expanding incentives for developers to build affordable homes. Streamlining the permitting process and exploring land use reforms could help accelerate the development of these projects.

To prevent displacement, the City could strengthen tenant protection laws, provide more rental assistance programs, and ensure that affordable housing is preserved as new developments are built. Rent control policies, combined with outreach and support for at-risk tenants, could also help prevent displacement.

For our unhoused residents, the City should continue to expand permanent supportive housing, improve access to emergency shelters, and provide comprehensive services that include mental health and addiction support. Collaborating with nonprofits, offering more transitional housing options, and improving outreach services would ensure that unhoused individuals are connected to the resources they need to regain stability.

Sunnyvale has taken significant steps to support its unhoused community, including emergency housing programs like temporary hotel placements during cold weather and outreach services provided by WeHOPE. The city has also allocated nearly \$30 million to fund 600 new affordable housing units, aiming to provide long-term stability for unhoused residents. Additionally, the Safe RV Parking Program offers a safe alternative for those living in vehicles.

While these efforts are promising, ongoing investment and expansion of services are needed to address the complex issue of homelessness and ensure sustainable solutions.
