RE: AB 1391 (Addis) Universal Funding for Universal Transitional Kindergarten *(as Amended March 24, 2025) –* **SUPPORT**

Dear Assemblymember Addis:

On behalf of the City of Sunnyvale, we want to express our support for AB 1391 which would provide universal funding for universal transitional kindergarten (UTK).

AB 1391 provides a fair and urgently needed solution by creating a mechanism to ensure community-funded districts receive the same UTK support as our state-funded peers. This bill aligns with the state's goal of UTK by making it genuinely accessible and sustainable for every district, regardless of their funding structure.

For the past decade, Sunnyvale schools have been left to fund transitional kindergarten (TK) out of existing resources, the vast majority of which, like any other school, are dedicated to existing teachers and support staff. This cost has become increasingly impossible to bear as more students have become eligible for TK, reaching full implementation next school year.

Current City of Sunnyvale policy places a high priority on supporting efforts to improve the availability and quality of education made available in Sunnyvale, supporting educational reforms that will cost-effectively result in better education and supporting reforms to the State's school formula based upon average daily attendance to recognize actual needs of funding for schools (Sunnyvale City Council Goal 5.1E and Policies 5.1E.1 and 5.1E.4). We believe universal transitional kindergarten accomplishes this goal and helps California's youth to excel in school. The City also partners with and supports the Sunnyvale Elementary School District's educational and enrichment programs and activities.
