It was great speaking with you yesterday. As discussed, I am formally filing a complaint regarding the parking situation on Samedra St. The issues are as follows: Students from Homestead High School are using Samedra St as their "parking lot". This problem is worsening due to the removal of off-street parking on S Mary Ave and Homestead Rd to make room for bicycle lanes. As the second house from Homestead Road, my property has been disproportionately impacted, leaving me and my visitors without off-street parking and significantly impairing our use of the property.
