# **Site Logistics**

- Provide proof of rental of a minimum of <u>2</u> portable toilets <u>1</u> of which must be ADA compliant, and <u>1</u> hand washing station(s).
- Pay a \$150.90 fee for the staffing of **One (1) on-site Park Worker III**, for (check the reason below).
  - o the monitoring of the event for **Two (2)** hours. Parks worker will inspect and ensure compliance to the park rules and special event conditions.
- Arrange a site meeting with Parks Supervisor (Jonathan Howard), 408-220-5601, jhoward@sunnyvale.ca.gov) to discuss the event layout and conditions of the permit. Be sure to bring the following to the meeting: COMPLETED

- Up-to-date site map
- Detailed event itinerary
- Delivery dates/times for the portable restrooms and dumpster (if required for event).
- Event organizer should plan to use a generator for event power. Outlets are not guaranteed to operate on the day of the event and have a 15-amp max.

### **Special Event Garbage Containers and Dumpster Requirements**

- As requested on your application, Ten (10) portable special event containers (Five (5) for trash, Five (5) for bottles/cans recycling) will be provided for your event at no-charge. Work with Mary to provide the following:
- Drop off and pick up location and time for the containers: Sunnyvale Presbyterian Church
- Contact information for the person who will be accepting the delivery
- It is recommended, but not required, to order a <u>One (1)</u> cubic yard dumpster for event waste from franchise hauler Specialty Solid Waste & Recycling and pay them directly. Call (408) 565-9900 to order. Let Mary know if you plan to order a dumpster.

Note: Based on 4/26/25 conversation with applicant on 3/26/25, garbage disposal options are:

- 1) order 1 CY dumpster and site on Taaffe St with Traffic's approval OR
- 2) self-haul to SMaRT Station, 301 Carl Rd., Sunnyvale and email Mary the receipts OR
- 3) self-haul to Sunnyvale Presbyterian Church's 3 CY garbage dumpster. The church has Tuesday garbage service so if the dumpster overflows with event waste, the church must call Sunnyvale Utilities at 408-730-7400 on Monday to request a special dump (charged service). Dumpster lids must always be able to completely close.

Additional pre-event conditions: Applicant to let Mary know in advance which disposal option they select.
