What motivated you to apply for this board or commission?

What do you think are major equity challenges facing the **Sunnyvale community?**

Within the Sunnyvale community, some equity challenges specifically affecting teens include access to affordable opportunities. While many programs, extracurriculars, and enrichment activities exist, they can be costly and are not accessible to all students in the area. Specifically relating to club sports, collegiate programs, research opportunities, and SAT and AP exam resources. With college admissions becoming increasingly competitive, students are seeking more extracurricular and enrichment experiences; however, when these programs cost more than their monthly rent, a gap forms between students who can afford opportunities and those who cannot. Mental health resources are also limited, and students should be able to access support easily and confidentially, without fear or barriers. Addressing these gaps is essential to ensure all teens have equal opportunities for personal growth, wellbeing, and community engagement.
