PUBLIC HEARINGS/GENERAL BUSINESS

2. [25-1068](#) Discussion and Possible Recommendation of One Council Priority Project Idea to the City Council

Planning Officer Shaunn Mendrin provided a brief overview of the process by which the Planning Commission will recommend one Council Priority Project (CPP) idea to the City Council for consideration.

Commissioner Pyne confirmed with Planning Officer Mendrin that each Councilmember may propose up to three CPPs per year.

Vice Chair Shukla shared her thoughts on possible CPP ideas, one of which the Planning Commission may choose to recommend to the City Council.

Commissioner Davis suggested that the City's Bicycle and Pedestrian Advisory Commission (BPAC) advise and provide guidance on transportation modes beyond biking and walking by overseeing matters related to automobiles, sidewalks, and walkways while ensuring accessibility for all users.

Commissioner Serrone presented the CPP idea that he and Commissioner Figone collaborated on. He discussed the ways this CPP idea would explore a universal housing design to accommodate a larger group of residents, particularly those with mobility limitations.

In response to Commissioner Davis' proposal, Commissioner Serrone stated that the City of Palo Alto has a Planning and Transportation Commission. Commissioner Serrone agreed that since our City's BPAC focuses primarily on bicyclists and pedestrians, our current approach overlooks matters involving other modes of transportation.

Vice Chair Shukla suggested exploring ways to streamline the Accessory Dwelling

Unit (ADU) construction process to increase the City's housing supply.

Commissioner Pyne confirmed with Planning Officer Mendrin that staff are already working on study issues pertaining to minimum parking requirements for residential uses (including single-family homes) and park dedication fees. For this reason, he advised the Planning Commission to recommend alternative CPP ideas to the City Council.

Commissioner Davis and Chair Iglesias spoke in support of the CPP idea presented by Commissioner Serrone.

Commissioner Pyne shared his observation that Commissioners including himself are in favor of the CPP idea presented by Commissioner Serrone, so a motion could be made in support of it.

Chair Iglesias opened the Public Hearing.

There were no public speakers for this agenda item.

Chair Iglesias closed the Public Hearing.

MOTION: Commissioner Davis moved, and Commissioner Pyne seconded the motion to recommend that the City Council consider a Council Priority Project that explores universal design housing for the City's residential developments as presented by Commissioner Serrone.

Commissioner Davis urged his fellow Commissioners to vote in favor of this CPP idea.

Commissioner Pyne voiced his support for the motion and shared his thoughts on other CPP ideas that were proposed.

Vice Chair Shukla expressed her support for the motion.

Chair Iglesias noted that there is value in streamlining the ADU construction process. He also shared his support of the proposed CPP idea that Commissioner Serrone and Commissioner Figone collaborated on and commented that it is an insightful and thoughtful recommendation.
