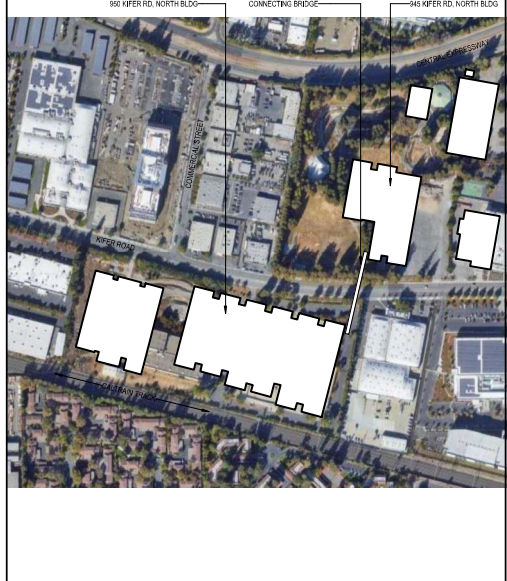

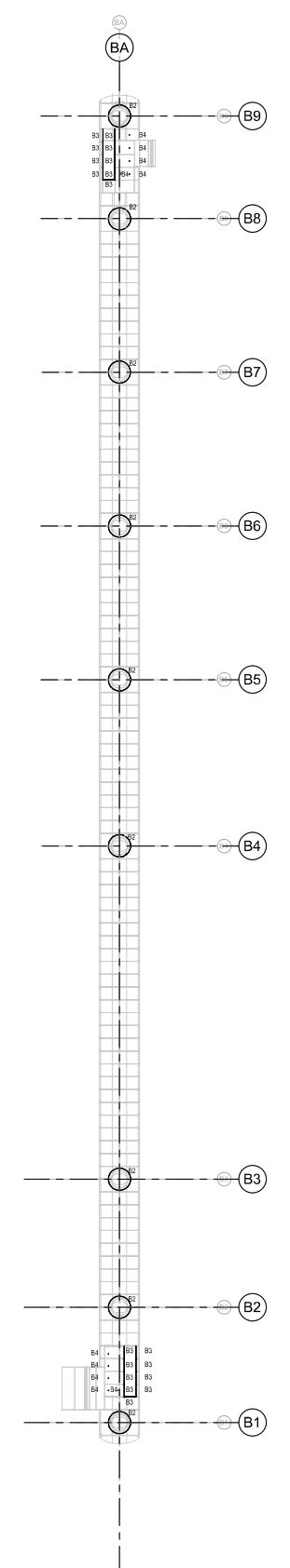

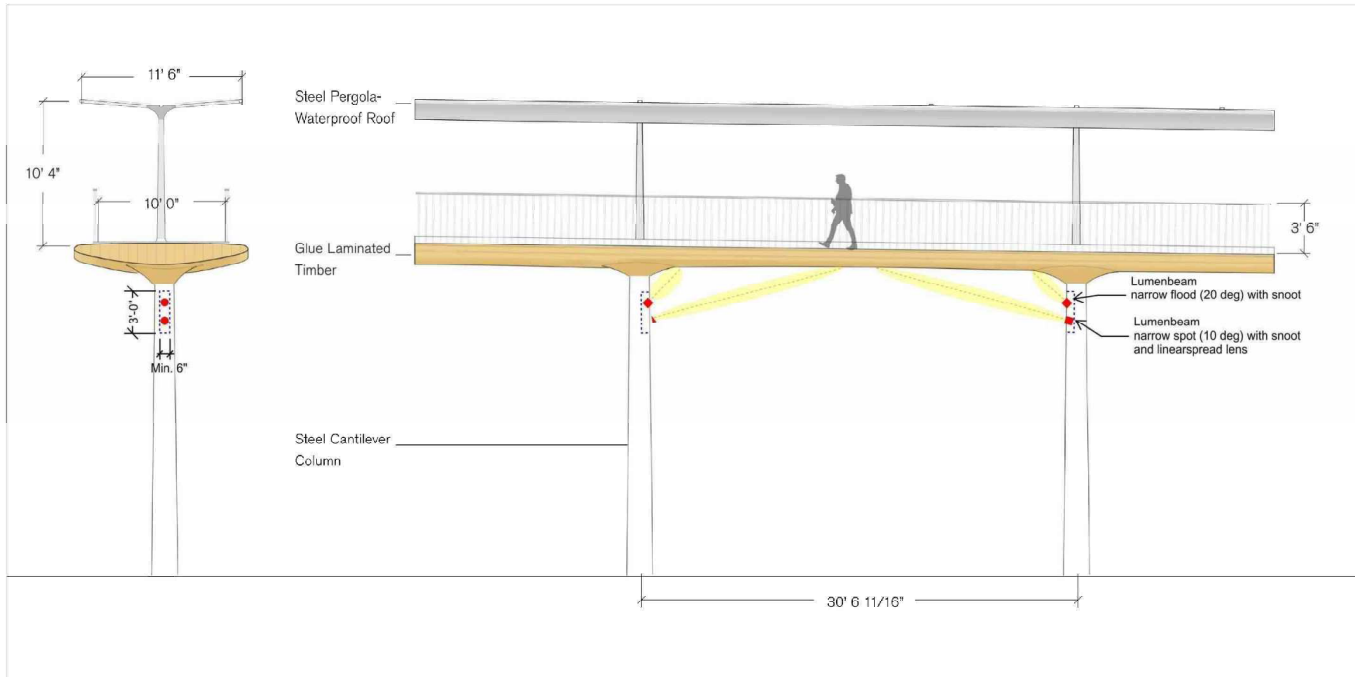


B BRIDGE UNDERSIDE CALCULATION PLAN

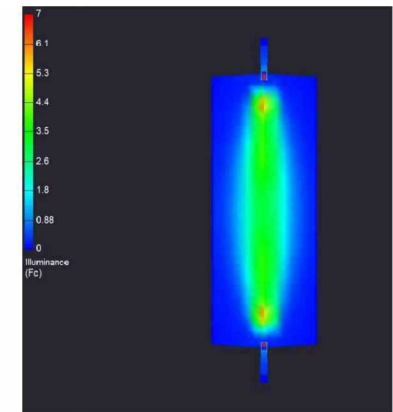
