Firstly, the traffic conditions are already really bad on lawrence expressway, high way 101 during peak hours. Even local traffic became agonal during rush hours. It often takes me 25 minutes or more one way to send my daughter to preschool where it is only 3 miles away and it should be only a 12 minutes drive according to google map. The planned additional 1000 new AMD units will bring traffic to an unbearable situation. Plus, there are numerous large high density communities already in construction along lawrence expressway like nearby 1000 units Nueva project and the Vale project itself .It wouldn't do any good to any existing residents nor the new residents.

My name is Fei and I am a resident living nearby in Deguigne Dr. I just heard the 1 AMD Place project keeps moving forward. I'd like raise some concerns.

In a nutshell, I strongly object to the development of **high density** community here.

- \* Traffic. As more and more people moved in, I have noticed the traffic condition is decreasing. The roads around are quite narrow (e.g. E Duane Ave only has one lane), the entrances to the highway are also limited. The high density community can only make things much worse, and nobody living nearby will be a winner.

RE: Draft and Final Environmental Impact Report for AMD Redevelopment Project

#### Dear Chair Howard:

My husband and I attended the Planning Commission Public Hearing on April 8, 2019. I appreciated the opportunity to speak on the AMD Redevelopment Project. I also wish to thank you for acknowledging my concerns regarding traffic conditions.

You posed the question regarding reducing the speed limit on E. Duane Ave. to 30 mph. The gentleman in charge of the traffic analysis explained it is a matter of state law and the Department of Public Works. Please see the attached "A" Vehicle Speed Limit Modification from the City Municipal Code.

I would like the City of Sunnyvale to pursue changing the speed limit due to the following reasons:

- 1. The City has rezoned this area over the past decade to various residential densities. This street is now a residential 2-lane street with a new public park, school and small neighborhood shopping center. The office/commercial buildings of the past are gone.
- 2. The AMD project will add a new net total of 4,327 daily trips as per the traffic impact analysis. It is highly likely the new trips will use E. Duane as the main route of travel in addition to the surrounding streets.
- 3. The surrounding streets all have 30 mph (or less) speed limits. Please see the attached map "B" showing streets and speed limits.
- 4. Even the very busy Fair Oaks Ave. is 30 mph. This is also a City designated truck route. Please see the attached truck route "C" from the City Municipal Code.
- 5. While it is nice to envision drivers adhere to speed limits, the reality is speeding vehicles can be seen and heard racing down E. Duane on a daily basis and the chances of getting caught by police are slim.
- 6. The new Indian Wells street with a roundabout will probably be a speed limit much lower. It makes no sense for E. Duane to be the only street that drivers can rush through along the nice new public parks where pedestrians and families with children may walk or bike along. Safety and quality of life should be a priority for the City.

My concerns regarding the upcoming projects at 1080 Stewart (Marriott Hotel) and 1060 Stewart (Public Storage) were ignored. The impact of a new 7-story hotel adding a total of 109 net new rooms next to a new 5-story Public Storage building expansion will certainly add to density and traffic, while changing the suburban look and character of this area. The City continues to permit variances in building heights as it has done with the AMD project. I believe the FEIR does not

factor in all the new vehicles and pollution generated by a hotel and public storage trips. The City should look at the totality of changes in this area and not just one project at a time.

The letter to Ms. Caruso dated December 17, 2018, written by Ms. Ellen Talbo from the County of Santa Clara, asks that "Prior to issuance of the Final EIR, the County requests that the City to re-evaluate the current percentages shown in the trip distribution and review it accordingly with the County Traffic Engineering staff as we believe it to be inaccurate."

The letter to Ms. Caruso dated December 13, 2018, from Mr. Frank Bellucci, President of the Public Safety Officers Association, states in part:

"Adding a substantial number of additional residents to the area will continue to deteriorate emergency response times."

"We believe that failure to analyze the impact of response times during commute hours is a flaw under the California Environmental Quality Act (CEQA)."

"Finally, the PSOA is concerned that the City of Sunnyvale is taking a project-by-project approach to its analysis of development project impacts. There are several major projects either recently approved or in various forms of the planning phases that have not been looked at collectively. We believe that this project follows the same pattern."

I have stated on record the current conditions of modified vehicles which produce super loud noise and terrorize our streets any time of day or night. The City can identify intersections where tire burning donuts occur just by looking at the tracks. Sideshows occur at the E. Duane/Stewart intersection, the Stewart/Santa Trinita intersection, the E. Duane/DeGuigne intersection as well as others near the area. The reason this neighborhood is so popular for reckless driving is that the escape route on E. Duane is fast and leads to Lawrence Expressway and U.S. 101 making it easy not to get caught. These activities are increasing and can only lead to more aggressive crimes.

I am getting the impression it will take an act of Congress to get the City of Sunnyvale to change its own city street speed limit. This change is for the benefit and safety of the current and future residents of Sunnyvale. Please advise how the City will address the above concerns and what action may be taken. Please share this letter with the other Planning Commission members and any department in the City that can address these issues.



<u>Title 10. VEHICLES AND TRAFFIOR Chapter 10.28. SPEED LIMITS</u>

#### 10.28.010. Modification of state law maximum speed.

- (a) Pursuant to the authority granted by the California Vehicle Code, it is determined upon the basis of engineering and traffic surveys that: as to certain streets or portions thereof, the speed limit permitted by state law outside the business and residence districts is greater than reasonable or safe under the conditions found to exist upon such streets. It is further determined that as to other streets or portions thereof, a speed greater than that permitted by state law would facilitate the orderly movement of vehicular traffic and would be reasonable and safe under the conditions found to exist upon such streets.
- (b) It is declared that the prima facie speed limit for each such street or portion thereof shall be as set forth in the city council resolution concerning "SPEED LIMITS" when signs are erected giving notice of such limits. Such resolution may be amended from time to time. ### 10.40.020. Established—Signs.

The following truck traffic routes within the city of Sunnyvale are hereby established for the movement of any truck as defined in Section 10.40.010:
