What new information about your I was appointed by the Sunnyvale City Council to the Heritage and Preservation Commission in 2021 and have served continuously till date. I have also served as Chairperson of the Heritage and Preservation Commission from 2022 until 2023.

> During my time as Commissioner, I have been a vocal member of the commission, asking pertinent questions and clarifying questions on specific agenda items presented. I have attended 89% of all Heritage and Preservation Commission meetings over the last four years.

Examples of my involvement on the Commission include:
