The school leadership took the issue seriously, met with the teachers, and made significant changes to the material to ensure it was more balanced and respectful.

> This experience reinforced my belief in the power of engagement, empathy, and fact-based dialogue. By approaching the issue collaboratively, we achieved a positive outcome that benefited all students, promoting fairness, understanding, and inclusion.
