Vincent Lui Page 2 of 6 Attended a few Sustainability Commissions meetings since late 2024. i learned that: - Sunnyvale has adopted a Climate Action Plan which is a 5-year plan that calls for a number of sustainability targets by 2030, with the aim to align the City's sustainability goals with CA State's targets by 2045. - The purpose of the Commission is to understand, assess and
	make recommendations on priorities and policy issues. From the few meetings i have attended in person and remotely, - I have seen the Commission intaking and asking questions to current studies and issues on certain topics (per the Action Plan schedule) but have not seen tangible outcome, recommendation or activities to arrive at recommendations from the Commission. So it is not clear to me (and perhaps not to other Sunnyvale residents) the work and accomplishment by the Commission. - I haven't observed much/if any community participation, nor any the Commission elaborating/discussing/addressing any of those community inputs at the monthly meeting. I do not see any feedback or dialogues during or post-meeting, therefore it is also not clear to me if the community's concerns are being addressed.
