Like many Santa Clara County cities, Sunnyvale is faced with problems stemming from traffic congestion and air pollution.

As a prospective board/commission member, I recognize that traffic congestion and air pollution are significant challenges for Sunnyvale, as they are for many cities in Santa Clara County.
