What role do you think public art plays in a city?	Art is powerful and multifaceted; art is a collective form of storytelling which mirrors a community's identity, history, and values. The Sunnyvale Public ArtI'd start by engaging directly with residents-especially historically
underrepresented groups-through listening sessions, surveys, and
partnerships with cultural organizations. Community input should
guide which stories, traditions, and art forms are elevated.

Another decision would be to create a wider definition of art which may not only be visual but literary, interactive, and perfuming. This inclusive view would encourage a wider part of the population to engage, participate, feel a sense of community, pride and belonging thus having a more stable community.

Infrastructure modernization to include building and emergent technologies inclusion, and the inclusion of underrepresented community groups towards developing digital skills.
Our main library's infrastructure is aging, with ongoing maintenance issues. The 2024 library bond measure, intended to solve those issues, failed. What solutions do you suggest?	When a bond measure fails it is generally due to not having had the support of a community before deciding of=n creating that measure. The community needs to see the value and stand with the goals and ideas of the measure for it to "stick" and become a reality. I do not doubt on the visionary aspects of whomever proposed that bod measure, but I also -as part of a community- know that the public s already strapped for cash int heir own lives which makes it impossible for anyone to back up spending capital in something that the value is not 100% apparent. By creating library programs and for them for a couple of cycles, attracting patrons to the library, making the library a place of community pride, the next time a bond measure proposal could have better results.

Offering better accessibility (such as discounted or free parking in public places for residents), enforcing parking regulations as so many of the overflow of cars for which the residents who do not have an available garage or carport park their vehicles in or near public parks, would increase the attendance tot hose areas for the residents in need of that contact with the environment, expansion activities and relaxation to improve their well-being.
