

**2026 Appointments for Consideration by Council**  
**Tuesday, January 13, 2026**

Every year, the City Council reviews three types of appointments: Appointments made by Council; Appointments made by the Mayor; and Appointments made by Outside Agencies. The list of appointments to be made is as follows:

**1. Appointments Made by Council:** Assignments that are at the discretion of the Council and are proposed to be ratified during the January 13, 2026, Council Meeting.

a. **Community Member Appointments:** Council may appoint a non-Councilmember to represent the City's interest on an intergovernmental body.

**3. Appointments Made by Outside Agencies:** Assignments included in this section are those where the Councilmember has, in accordance with City Policy, advised staff in advance. Councilmembers must follow the application process of the appointing agency. These appointments typically have a term length, however Council must ratify each re-appointment annually.

The Cities Association of Santa Clara County (CASCC) oversees the appointment process for several of these appointments and announces vacancies as they occur. CASCC or City staff forwards all announcements for appointments that Council are eligible to apply for.
