4. What motivated you to apply for this board or commission?

1. Artist in Sunnyvale.

- I am a technologist by day, and artist by night. As an artist, I created artwork for non profit organizations, including sculptures that were sold in charity auction fundraisers. Please see the Appendix. During the pandemic, I felt inspired to produce art to bring joy to the community. Over the last year, I launched 14 art displays that are accessible to the public, in the front yard of my house in downtown Sunnyvale. The response from residents has been tremendous, as evidenced by people frequently taking pictures with the artwork, signing the guest book and commenting on Instagram. I am honored that Mayor Larry Klein has visited many times and posted pictures on Facebook.

2. Keen interest to partner with the City of Sunnyvale to bring art to the community.

- Art has an incredible ability to connect people and transcend cultures. I would love to work with the City to strengthen existing art programs, and incorporate art into additional events as appropriate, such as the Holiday Tree Lighting ceremony and Halloween Pet Parade.

5. What skills or attributes can you bring to this board or commission?

- ARTIST. As an artist, my artwork has been featured on the New York Times, MSN.com, and Better Homes and Gardens magazine. The sculptures that I made for the non-profit Guide Dogs for the Blind were sold at fundraising auctions at the Ritz Carlton hotel. I made costumes for the non-profit World Wildlife Fund that drove awareness for their fundraisers, raising millions in donations each year.

- MUSICIAN. As a musician, I have passed the Royal Conservatory of Music's Level 10 exam, the highest level for non professionals. I have performed in community theater, choirs, and as a pianist at the El Camino Hospital in Mountain View and Hopkins Manor (seniors living facility in Palo Alto).

- NON PROFITCOUNCIL MEMBER. As National Council member at World Wildlife Fund (WWF), a non profit with \$250 million in annual revenue, I co-founded the Global Coalition against Wildlife Trafficking Online with WWF's leadership, and secured commitment from major tech companies in Silicon Valley to ban selling endangered animal products online.

6. The primary role of a board or commission member is to provide advice to City Council on policy issues that are within the scope of that board or commission. With this in mind, what steps would you take to effectively exercise this specific board or commission role?

1. Partner with the City of Sunnyvale's staff, Arts Commission and City Council.

The City of Sunnyvale's staff, Arts Commission and City Council have years of experience in delivering public art programs to the community. My first step is to learn from them on what worked well and what didn't.

2. Channel input from Sunnyvale residents.

Since launching the public art bench in the front yard of my house in Sunnyvale (see question #4), I have built a community of hundreds of people on social media, comprising mostly of Sunnyvale residents who visited the art bench. If appropriate, I would use social media to gather feedback about public art from the Sunnyvale community.

3. Learn from Art Commissions in nearby communities.

I would seek to learn from the Art Commissions in nearby cities, including Mountain View, Los Altos, Palo Alto and San Jose, on what worked well for them, and partner with City of Sunnyvale staff to evaluate what may be a fit for Sunnyvale.

8. Briefly describe your current or last occupation.

I have been working at Google in Sunnyvale and Mountain View since 2004. During this time, I have held various leadership roles in product development, operations and environmental sustainability. I have received three Executive Management Awards and a Founder's Award at Google.

Currently, I manage a Technical Program Management team and run operations for a team of 300 people for the Google Assistant. Google Assistant is the product that responds when you ask questions to your Android phone, such as, "Hey Google, how's the weather?"

9. Briefly describe what you learned by attending a meeting of the City Council, board or commission. Describe what improvements you would suggest the City consider.

1. Approval and funding. Funding is available from the City's public art fund, and the Parks renovation fund if applicable. In addition to residents, public art decisions in private development need to factor in the interests of private developers.

2. Location of public art. The City has the ability to install art on public lands. In the case of El Camino Real, VTA and the County have jurisdiction over those areas.

3. The team. I am impressed by the City staff, Arts Commissioners and Mayor Larry Klein's commitment to public art. I admire City staff's resilience and creativity in re-imagining how to deliver Hands on the Arts, so that it is safe under covid conditions.

10. Describe your involvement in community activities, volunteer and civic organizations.

As described above in questions 5 and 7, I serve as a Board member and advisor at several non profits.

As Board member of Rainforest Connection, a San Francisco based non profit with 50 employees whose mission is to use technology to prevent illegal deforestation, my role as Board member is to ensure that the organization delivers measurable impact against its mission.

In addition to my formal board roles, I have also been involved with the local non profit Humane Society Silicon Valley for over 10 years. As an ambassador, I have recruited dozens of volunteers for special events, and ran annual fundraisers for them that raised hundreds of thousands of dollars in donations.

#### We are looking for someone who has demonstrated interest in housing and human services issues

7. Evaluate the quality and adequacy of the housing programs that serve the Sunnyvale community.

My opinions are based on reading most city and HHS short- and long-range plan documents, plus knowledge of some community-assisted housing projects from my SCS food delivery runs.

1. The HHS priorities are appropriate, i.e. emphasize supply-side, demand-side, age-friendly, and mobile home solutions. 2. My view is the quality of housing at many community-supported projects such as Onizuka Crossings, Homestead Park, and some Mid-Pen properties are very good. These properties clearly benefit the community.

3. However, based on reading the data on the number of residents (many seniors) who pay 50% of more of their income on housing, it is clear that the supply of affordable units and funds for rental assistance far outstrips demand. Based on my experience with SCS Community Leaders, I know funds for temporary rental assistance are very limited, and the wait-time for federal housing vouchers is measured in years.

4. Rising rents and the pandemic have worsened the housing situation, widened historical inequities, and increased the number of unhoused residents. My view is the recent situation with the Fair Oaks Park encampment exposed some gaps in ownership between the City and the County of programs and services for unhoused residents.

8. Evaluate the quality and availability of the human services programs that serve the Sunnyvale community.

My opinions are based on listening to funding proposals at recent HHS meetings and my experience with the SCS Community Leaders Program.

1. It is good that CDBG capital funds are available to fund high-priority projects, notably WorkFirst and outfitting the new SCS facility (freezer).

2. It is also clear after listening to the HHS requests from various regional organizations for city funding that the demand for these services funding far outstrips the city's ability to fund services. A difficult HHS decision must be to decide who gets city funding and how much.

3. Human services are delivered via a variety of local, county, and regional organizations. Target recipients may not be aware of all the services available to them or have the time to research options. There is a need for more "one-stop" consolidator services to help guide residents to all the solutions available to them. I have spent a lifetime following global warming and other environmental issues with increasing alarm. Two decades after putting down roots here, the request for Sustainability Commission applications is a clarion call to direct action.

In my career, I have been fortunate enough to contribute to 3 world-changing products. Having learned to dive into details and think about interconnections, it has become apparent that sustainability is more important than all of those accomplishments combined. If we do not get this right, nothing else really matters.

While the threat is as obvious as smoke-filled skies, we now have the economic, behavioral, and analytical tools to bend curves in the right direction. In addition to putting up more solar panels, we can use our knowledge to effect human-centered land use, more inclusive transportation, energy efficiency, and a wide array of other enhancements that save money, foster health, and reduce stress while advancing our global goals. On my high school speech team, I devoted one year to warning about the Greenhouse Effect, one year to discussing our over-reliance on automobiles, and one year to advocating for a more sustainable Energy Policy. I actually qualified the California State High School Speech Tournament two of those years. Back then, environmentalism was a dirty word with a large percentage of the population. The balancing act was to raise concern about systems that defined our world while reassuring audiences that my proposals would protect their quality of life. Over time, I came to appreciate that our hurdles are often more political than technological. I do hope that we can recapture the spirit of the Clean Air Act, Clean Water Act, and Montreal Protocol. But while we are waiting for national governments, we can act locally.

I am a server software developer for a large, highly-watched corporation with hundreds of millions of customers. I have worked on products that support tens of thousands of simultaneous requests from around the world. We design and maintain complex systems with many dependencies on other teams and applications. While there is much responsibility, there is also a great sense of fulfillment knowing that so many people use and enjoy what we create.

I have been a part of many high pressure, high profile projects. In difficult times, it is important to accept inconvenient news, acknowledge and allay the concerns of others (as well as myself), stay calm, identify actionable next steps, and make sure everyone knows what to do. When we can take a breath, it is useful to look for and adopt good practices that make us more capable and resilient. Likewise, addressing climate change and other environmental threats also requires reaching out to stakeholders, navigating complex systems and dependencies, and partnering with others. I am eager to apply my skills to the challenge of our generation.

Both the Commission and Council meetings were inspiring demonstrations of how to discuss challenges. Compared to other government meetings I have witnessed, Sunnyvale's were uniquely polite and respectful. Spreading affability is like saving money in the bank for when we face inevitable disagreement.

The very contentious topic of Prefabricated Housing was particularly enlightening. I really liked how the City Council studiously avoided taking a side. Being neutral allows government to leverage its authority to incorporate the energy and expertise of citizens in coming to solutions such as a Memorandum of Understanding.

At the same time, there was a nagging concern that we were not hearing all voices. People are busy, and many are intimidated by unfamiliarity or language. For those that did speak, I wondered what would happen if we could ask them questions and engage in a dialogue. Of course, there are no easy answers, and we need to move forward in a timely fashion. Still, it is useful to acknowledge this difficulty and continually look for ways to reach out to more residents.

For over a decade, I have served as a the Treasurer for the Palo Alto Run Club. Responsibilities include overseeing our budget, disbursing payments, participating in monthly meetings, and providing sound spending advice.

As a software developer, I initiated a couple of CD recycling drives on a campus with thousands of people. I have participated in several California Coastal Cleanup days. Being on both sides of volunteering has taught me that small actions by many people really do add up. Furthermore, given the opportunity, many people will do the right thing. Combining these forces can be transformative, and government has the reach and influence unleash this power.

In addition, the activities reinforced the maxim that an ounce of prevention is worth a pound of cure. Not producing a styrofoam cup is better than me picking it out of ankle-deep Baylands mud, which is better than micro-foam becoming part of tonight's seafood dinner.

Because bicycles are so much more efficient than cars, relatively inexpensive changes can result in significant improvements for cyclists. For example, replacing underused auto-lanes with bike lanes transformed Evelyn Avenue into a bicycle highway. Going forward, converting a couple of parking spots into 16 bike racks on Murphy Street would create a highly visible bicycle magnet (versus the often-blocked loops currently sprinkled on the sidewalk) and promote cycling to thousands of Farmers' Market shoppers.

While developing policies, we should seek out and work with those who can be negatively affected, especially since so many historically disadvantaged communities tend to feel the brunt of change. Their input and buy-in can lead to solutions with fewer unwanted side effects and more obvious positives. Perhaps we can develop unexpected partners by sharing benefits and creating more jobs. While difficult, some of our most rewarding work will be finding social, economic, and environmental synergies that open possibilities unimagined before.

4. What motivated you to apply for this board or commission?

As a climate scientist, I am interested in ways to reduce fossil fuel usage and subsequent emissions. At least in the Beforetimes, I had been biking to work (and locally) for the last 5 years, but the ability to do that is strongly dependent on where you are and where you're going (and the infrastructure between), and even under the best of circumstances can still be terrifying regarding the cars. The same is true for other individual actions (composting, public transit, reducing plastic consumption); we need systemic support to make the sustainable option the easiest one. I see the goals of both the biking and sustainability boards as fairly in line with one another, as transportation is one of the largest sources of emissions (both CO2 and other pollutants which affect air quality), so improving sustainability in transit will help reduce emissions, and vice versa (as nobody wants to bike or walk when the air quality is bad). I hope to use my expertise to help further the goals of these boards on a larger, localized scale.

#### 5. What skills or attributes can you bring to this board or commission?

As a climate scientist, I am aware of the various issues surrounding fossil fuel emissions and the inertia in our systems which are making that difficult. I am accustomed to thinking critically about many of these issues, and thinking from a holistic systems perspective. I endeavour to reduce my own emissions (i.e., biking, walking, or using public transit as much as possible), and thus am quite familiar with many of the limitations and concerns (particularly safety) of these methods of transport. I think my professional experience surrounding climate change, and my personal experience trying to reduce my own (transportation-related) emissions, would both be valuable contributions to both the bicycle/pedestrian and sustainability commissions.

6. The primary role of a board or commission member is to provide advice to City Council on policy issues that are within the scope of that board or commission. With this in mind, what steps would you take to effectively exercise this specific board or commission role?

I assume there is some amount of two-way interaction with an advisory board, i.e., providing advice to specific policy issues which come before the Council through other means, and also bringing potential issues under the purview of the board to the Council. For the former, I would seek to provide the evidence-based advice using the best information at my disposal, whether that be scientific studies (if available), or the opinions of other residents/cyclists in the area. The latter would be much the same; based on either published evidence or experience (my own or of others) I would seek to bring emergent issues to the attention of the council.

I imagine that much of the advisory role for the bicycle and pedestrian commission would be regarding implementation of the Vision Zero commitment, whereas for the Sustainability Commission, the focus will be on the implementation of the climate action playbook. Becoming more familiar with these would be a first step. Also, as I am only one person, soliciting input from other members of the community would also be necessary to get other perspectives regarding potential policy issues.

I am a research scientist studying the effects of smoke particles on clouds, largely using airborne datasets collected off the western coast of southern Africa. These so-called "aerosol cloud interactions" are essentially the largest remaining question mark in our understanding of the physical climate system, as there can often be competing effects in play (i.e., making the clouds brighter and more reflective, or reducing cloud cover for the opposite effect), and since they're fairly short-lived components in the atmosphere (usually they are removed by rain), their effects are localized rather than global (in contrast to the effects of long-lived greenhouse gases).

9. Briefly describe what you learned by attending a meeting of the City Council, board or commission. Describe what improvements you would suggest the City consider.

I have attended a couple city council meetings and outreach events for the sustainability plan, and a bicycle path touring event, in the Beforetimes, and watched the latest commission virtual meetings. I think it's quite useful to have these meetings livestreamed and available for remote/later viewing. During COVID, I've also come to value a concise meeting where time limits are enforced on the agenda, but also how difficult that is to do. Aside from that I don't have any suggestions for improvements.

My volunteer service largely focuses on STEM outreach; I have participated in Skype a Scientist with K-12 students, and several similar programs throughout the years. I particularly enjoy outreach to students who are traditionally underrepresented in STEM fields, and emphasizing the urgency behind, for example, the peer-reviewed science in the National Climate Assessments or the Intergovernmental Panel on Climate Change Assessment Reports. 2. Like many cities in Santa Clara County, Sunnyvale is faced with problems stemming from traffic congestion and air pollution. Suggest ways the City can improve facilities for bicyclists and improve bicycling education and safety programs for motorists, cyclists and pedestrians?

I've said before, a lot of my major bike lane issues are with Mountain View (bike lanes cannot overlap with street parking), but for Sunnyvale there are several places where a protected (or even marked) bike lane could go a long way towards encouraging use; Maude (east-west) has greatly improved on the Sunnyvale side in the last couple years with the addition of a bike lane, but Sunnyvale-Saratoga is still sort of sketchy (north of the train tracks; there are big potholes which have only been filled in to car standards so you have to swerve into traffic; plus, no bike lane). Sunnyvale-Saratoga (and then Borregas) is a major artery which gets up to the paths along the bay, so better infrastructure here would be good.

Ideally, though I'm not sure how feasible it is, I'd like to see a series of bike paths (much like Stevens Creek) completely isolated from cars. In addition to the issue of physical safety, there's an increasing body of research indicating that emissions (and thus air quality and the associated health impacts) are drastically lower on streets with fewer cars. I have the strong impression that the demand is there (there's a distinct bicycle "rush hour" along Evelyn), but safety and infrastructure needs to be improved for adoption. Another issue which I'm not sure how feasible it is for Sunnyvale specifically to tackle, but motorist education and situational awareness of bicycles needs to be drastically improved (or, perhaps easier, simply move the bikes away from the cars to solve this problem).

The optimist in me thinks "awareness" would go a long way (nobody needs to be idling their cars in the parking lot), but the pragmatist in me thinks more on the lines of "to reduce [emissions/pollution/waste], you need to make the better option the default."

To me, the largest challenge seems to be how to reduce emissions in older buildings and in rentals (i.e., where the ratepayers and the owners are two different parties), since there's no financial incentive for the owners to reduce energy costs through efficiency. But efficiency is the epitome of a low-hanging fruit, so improving communication and incentives (or alternately, mandates) for owners to upgrade their properties would I think go a long way to reducing emissions in the long term. Encouraging alternatives to single-occupancy vehicles (increasing public transit and cycling infrastructure) is another big one, as is reducing non-CO2 pollution such as single-use plastics (particularly in e.g. grocery stores and restaurants). I'd also love to see if we can get local grocery stores to switch away from HFCs: none of ours are on here 15. Sustainability Commissioners will need to consider social, economic and environmental issues when addressing sustainability policy issues. How does one achieve a balanced community?

Short answer: not easily. I think there will always be pushback when any changes are implemented, either due to vested interests or simply behavioral inertia. I believe sustainability is something which ultimately will benefit the vast majority of people, but the method of implementation matters. There has to be buy-in from the community, or the changes will not stick. Finding the appropriate framing for a particular audience (e.g., connecting with the main values or priorities of a person or group) is critical, though this can often be an iterative process. One also has to be aware of the issues of environmental justice: that those who will be most impacted by a changing climate are often those who are least able to adapt to the anticipated changes (or pay for increased costs, if sustainability measures result in an increased financial burden), so outreach to these groups must be considered. At the end though, sustainability is something we cannot afford to not do any longer than we already have, and every action matters. I think being aware of the nuances and the difficulties of this issue is an important first step towards a successful transition.
