**Subject:** Relocation of Toyota Sculpture

This memo is to notify the Arts Commission that a request from Toyota to relocate a public art piece has been approved. *Dos Orbitos*, by Brad Howe, was installed in 2004 and located at 898 W. El Camino Real. Toyota has requested to move the abstract, stainless steel sculpture as part of their facility remodel.

Currently, the sculpture is located to the left of the service shop driveway adjacent to the sidewalk along El Camino Real. The relocation will move the sculpture to the other side of the same driveway approximately 74 feet to the east (right). The new location will also have a smaller set back from the public sidewalk at approximately 5 feet, as opposed to 8 feet at the original location.

Staff has reviewed and approved the relocation request, as the new location still meets the original conditions of approval set forth at the July 21, 2004 Arts Commission meeting. The new location will also allow for unobstructed viewing by passing motorists, pedestrians and visitors to the dealership.
