SUBJECT

Certification of November 8, 2022 Election Results - City Council Districts 3 and 5

BACKGROUND AND DISCUSSION

A General Municipal Election was held November 8, 2022 for the purpose of electing Council Members to City Council Districts 3 and 5. The Santa Clara County Registrar of Voters (ROV) canvassed the returns of the election and transmitted a Certification of Election Results to the City Clerk on December 8, 2022. Sunnyvale City Charter Section 601 provides that the four-year terms shall commence at the first regular meeting in January, at which the Council certifies the election results.

On December 12, 2022, Justin Jun-Ren Wang filed a request for a Voter Initiated Recount with the ROV. On December 27, 2022, the ROV reported the Voter Initiated Recount resulted in a tie between the two candidates. A tiebreaker for City Council District 3 is scheduled for Tuesday, January 3, 2023 (see Attachment 2).

The attached Resolution includes the December 27, 2022 Revised Certificate of Election Results for City Council District 3 along with the December 8, 2022 Certificate of Elections Results for City Council District 5.

Pursuant to California Elections Code Section 10263 and City Charter Section 601, the attached resolution details the number of votes cast and percentage of the vote received by each candidate, and declares elected the following persons who have received the highest number of votes cast for each office:

Councilmember District Number 3: *Pending Jan. 3, 2023 Tiebreaker*
Councilmember District Number 5: Richard Mehlinger

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE DECLARING CANVASS OF RETURNS AND RESULTS OF THE CONSOLIDATED GENERAL MUNICIPAL ELECTIONS HELD ON NOVEMBER 8, 2022, FOR THE ELECTION OF COUNCILMEMBERS TO CITY COUNCIL DISTRICTS 3 AND 5, AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, the City Council of the City of Sunnyvale duly called and ordered held in the City on Tuesday, November 8, 2022, a Consolidated General Municipal Election pursuant to Sunnyvale City Charter Section 1400 to elect Councilmembers to Districts 1, 3, and 5; and

WHEREAS, as of the close of the nomination period on Friday, August 12, 2022, only one person filed nomination papers to run for the office of City Councilmember representing District 1, and the City Council timely took action pursuant to Elections Code Section 10229 to appoint Linda Sell to City Council District 1 for a full term of four years, and cancel the election for City Council District 1 (Resolution No. 1143-22); and

WHEREAS, the election for City Council Districts 3 and 5 was held on November 8, 2022, and pursuant to the applicable provisions of the Elections Code of the State of California, the Registrar of Voters of the County of Santa Clara has duly canvassed the votes cast by the electors in the City of Sunnyvale upon the offices hereinafter set forth, and has supplied to the City Council the Certificate of Election Results and the final results of the votes cast, which are attached as Exhibit "A;" and

WHEREAS, the election for City Council District 3 resulted in a tie of votes cast for both candidates; and

WHEREAS, a by lot tiebreaker held pursuant to Elections Code Section 15651 for City Council District 3 was conducted by the Elections Office/City Clerk on January 3, 2023, resulting in determination of _____ as Council Elect for City Council District 3; and

WHEREAS, Sunnyvale City Charter Section 601 provides that the City Council shall certify the election results for the city councilmember elections at the first regular meeting in January.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SUNNYVALE DOES RESOLVE, DECLARE, DETERMINE AND ORDER THAT:

1. The total number of votes cast in the City of Sunnyvale at the Consolidated General Municipal Election, and the number of votes cast in each precinct for the persons and respective offices to be filled at the Consolidated General Municipal Election, are as listed in Exhibit "A," which is incorporated herein by this reference.



SUBJECT

Selection of Vice Mayor for a One-Year Term Effective January 4, 2022

DISCUSSION

City Charter section 608 (Attachment 1) requires the City Council to designate one of its members to serve as Vice Mayor at the first regular meeting in January at which the City Council certifies the election results, following the General Municipal Election. The Council will follow Council Policy 7.3.10, which outlines the process for filling the position of Vice Mayor.

The Vice Mayor is selected following the procedures set forth in Council Policy 7.3.10 (Attachment 2). In accordance with that policy, a study session was held on December 6, 2022 to allow Councilmembers and Councilmembers-Elect, if applicable, the opportunity to express interest in the position of Vice Mayor. At that meeting, Councilmembers Melton and Din expressed interest in serving as Vice Mayor for the one-year term. Expressing interest in the position is not a prerequisite for being nominated to serve as the Vice Mayor.

At the first regular meeting in January, at which the City Council shall certify the election results, following each General Municipal Election, and the first regular meeting in January in odd-numbered years, the City Council shall also designate one of its members as Vice Mayor. The Vice Mayor shall perform the duties of the Mayor during his/her absence or disability. (Amended effective December 31, 1975, December 21, 1976, December 23, 1982, November 30, 1995, November 28, 2007 and May 7, 2020: previously Section 705)

Policy 7.3.10 Vice Mayor Selection

POLICY PURPOSE:

Section 608 of the City Charter provides that the City Council shall select one of its members to serve as Vice Mayor. The Vice Mayor can be removed by super majority (five) votes of the Council. The Vice Mayor serves at the pleasure of the Council. The Charter does not specify the method of selection. Section 616 of the Charter provides that the Council shall establish rules of conduct of its proceedings. This policy specifies the time and method of Vice Mayor selection. It is intended to supplement Sections 608, and 616 of the City Charter and in no way conflict with those provisions.

POLICY STATEMENT:

The City Charter provides the terms of office and certain procedural requirements for the selection and removal of the Vice Mayor, and these Charter provisions are incorporated into this policy. The City Council recognizes the need to establish an orderly process of selection of the Vice Mayor.

1. Should the Vice Mayor's office become vacant during a term for whatever reason (i.e. resignation, death, disability, Council vote), the Councilmember selected to fill the vacancy shall serve the remainder of the unexpired term.
2. Agenda for Selection of Vice Mayor
 - A. During Election Years:
 - (I) Between Election Day and the first meeting in January, Council shall schedule a study session during which Councilmembers and Councilmembers-elect shall have the opportunity to express interest in the position of Vice Mayor.
 - (II) At the first regular meeting in January, the City Council shall certify the election results following each General Municipal Election.
 - (III) The certification of the election results shall directly follow approval of minutes as a Special Order of the Day.
 - (IV) After results are certified, Councilmembers leaving office shall be excused and newly elected members shall be seated.
 - (V) The next item of business shall be selection of the Vice Mayor.
 - B. During Non-Election Years:
 - (I) Between November 1 and the first regular meeting in January, Council shall schedule a study session during which Councilmembers shall have the opportunity to express interest in the position of Vice Mayor.

COUNCIL POLICY MANUAL

3. Nomination and Selection Process for Vice Mayor.

A. Councilmembers shall select a Vice Mayor who best exhibits the following criteria:

- (I) Leadership. The candidate has a vision for the City and clearly defined goals that other Councilmembers support. The candidate recognizes Sunnyvale's role in regional issues as well.
- (II) Executive skills. In the absence of the Mayor, the candidate can run public hearings efficiently so that as many members of the public as possible are able to provide input on Council decisions. The candidate works well with city staff but does not take direction from staff.
- (III) Integrity. The candidate maintains the highest possible ethical standards, works well with all Councilmembers, has the courage to take an unpopular position if it is best for the City, rises above petty disputes, remains calm in a crisis, and seeks recognition for the City more than personal acclaim.
- (IV) Commitment. The candidate is willing and able to devote sufficient time to the role of Vice Mayor in order to perform it properly, is supportive of the community and is supported by the community. The candidate's past actions have been for the City's benefit rather than being self-serving.

B. Nominations:

The Mayor shall ask the Council for nominations for the position of the Vice Mayor. Any of the other Councilmembers may nominate someone other than himself or herself (including the incumbent) for the position. The Mayor shall ask each nominated Councilmember if he or she is willing to serve before declaring that person nominated. If there are no nominations, the Mayor may make a nomination. When it appears that no further nominations will be made, the Mayor shall announce that the nominations are closed.

C. Candidate Statements

If more than one Councilmember has been nominated, the Mayor shall allow each nominated candidate to speak briefly on his or own behalf. Nominees shall speak in the order in which they were nominated.

D. Voting:

All Councilmembers are strongly urged to be present for this vote. If for some reason a Councilmember cannot be present, they will be allowed to

teleconference and vote, as prescribed below, and to voice their opinion in regards to the candidate.

(I) Only One Candidate

If only one Councilmember has been nominated, the Mayor shall declare that individual to be elected Vice Mayor by unanimous consent.

(II) More than One Candidate

- (a) Votes will be taken by electronic vote unless a Councilmember participates via teleconference, in which case all votes will be taken by roll call vote. The order of roll call vote shall be determined by random drawing by the City Clerk. Councilmembers calling in will state their vote according to the order determined by random drawing.
- (b) Each Councilmember is entitled to vote for only one candidate. If more than one Councilmember has been nominated, the Mayor shall call for a vote of the first one nominated. If that candidate has received four or more votes, the Mayor shall declare that candidate elected and the voting concluded. If not, the Mayor shall call for a vote for the second candidate in the same manner. The candidate receiving four or more votes shall be declared the Vice Mayor.
- (c) In the case of a tie, a vote shall be held among all six Councilmembers and the Mayor to break the tie. For example, in the case of three candidates, if candidate A gets three votes, candidate B gets two votes, and candidate C gets two votes, all six Councilmembers and the Mayor vote on Candidates B and C. If candidate C gets the most votes, the final vote will be held between Candidates A and C.
- (d) The election process shall continue until one candidate has at least four votes and is declared to be elected.

E. Public Record for Ballots Cast

The City Clerk shall announce all votes cast by each Councilmember for the record. The votes of each Councilmember shall be included in the minutes of the meeting.

5. Mid-Term Vacancies.

If the Vice Mayor position becomes vacant during the course of the Vice Mayor's term, the City Clerk shall place an agenda item to select a new Vice Mayor on the agenda of the meeting when such vacancy is declared to exist. The Mayor, whoever is appropriate, shall preside over the selection.

SUBJECT

Appoint Councilmembers to Intergovernmental Assignments; Ratify Appointments of Councilmembers made by Outside Agencies; Take Action to Modify, Create, or Terminate Council Subcommittees

BACKGROUND

On December 6, 2022, the City Council held a Study Session to review their intergovernmental (IGR) assignments and stated their interest to continue, withdraw, or make available to other councilmembers for 2023. Councilmembers also expressed interest in serving on other assignments.

The purpose of this report is for Council to review and possibly ratify Councilmember appointments as presented. Appointees represent the City's interests and influence policies and regulations of other agencies. With a few minor exceptions, all Council appointments are made annually in January; at this time, Council also considers ratifying appointments made by outside agencies.

EXISTING POLICY

Council Policy 7.4.12, *Council Appointments to Intergovernmental Agencies*

Council Policy 7.4.13, *Council Subcommittees and Council- or Mayor-Created Advisory Task Forces*

ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" with the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378 (b)(5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment.

DISCUSSION

When making IGR appointments, Council considers the City's overall intergovernmental priorities as well as the particular interests and backgrounds of individual Councilmembers. The 2023 IGR Appointments for Consideration (Attachment 1) lists for reference the names of all interested parties and number of appointments available. The 2023 Council IGR Review Forms (Attachment 2) expresses the interest of Councilmembers to continue in their existing assignments (retain), withdraw (release) or make available (offer) assignments for other interested councilmembers.

Appointments made by the Mayor are provided for information only; the Mayor will make his appointments after the January 3 meeting.

Bay Area Water Supply and Conservation Agency (BAWSCA) Appointment

During the December 6, 2022 Council Study Session, Former Councilmember Gustav Larsson requested that the current City Council reappointment him to the Bay Area Water Supply and Conservation Agency (BAWSCA) and to the San Francisco Bay Area Regional Water System Financing Authority (RFA) for a four-year term commencing July 2023 to June 2027 but has committed to resign in January 2024.

Former Councilmember Gustav Larsson also serves as Board Chair for BAWSCA and RFA until January 19, 2023. Former Councilmember Gustav Larsson has requested to continue as Chair for one more year, January 19, 2023 to January 18, 2024.

The Bay Area Water Supply and Conservation Agency (BAWSCA) is an independent agency that was created in 2003 pursuant to Assembly Bill 2058. Sunnyvale was one of the agencies that took part in creating BAWSCA and appoints one director to the BAWSCA Board of Directors. The San Francisco Regional Water System Financing Authority (RFA) was created in 2002 by the State legislature to assist in funding the San Francisco regional water improvements. Water Code Section 81338 sets forth the term of each BAWSCA director and states that “[e]ach director shall serve a term of four years” and provides that “a vacancy on the board shall be filled by the respective appointing authority...” There is no provision for the “respective appointing authority” to rescind its appointment. The only requirement to be appointed is that the appointee be a registered voter residing within the boundaries of the member public entity whose governing board appoints him or her. The term of office and lack of authority to rescind its appointment for the RFA mirrors the BAWSCA statutory language and is found in Water Code Section 81631. The four-year term of former Councilmember Gustav Larsson on the Board of Directors on BAWSCA and the RFA will end on June 30, 2023. State legislation authorizes each member agency’s governing board to appoint a board member, however they do not have the authority to remove them from the board.

It should be noted that the staff report for making an appointment to BAWSCA and RFA in 2011 stated that “[t]he appointee to BAWSCA and the Authority need not be a council member, and is **not recallable** by the City once appointed.” (emphasis added) (RTC No. 11-088 - see Attachment 4)

Furthermore, in 2014 former Councilmember Larsson was appointed to BAWSCA after former Councilmember Griffith resigned from the BAWSCA board and created a vacancy, which then allowed the City Council to appoint former Councilmember Larsson. The following text was included in Attachment 1, entitled “Proposed the 2014 IGR assignments” (RTC No. 14-0007):

Note: This assignment has a set term; any vacancy will be appointed by Council for the remainder of the original term.)

Council Policy 7.4.3, Section I.C. states:

“The term of office for the Sunnyvale representative shall be in accordance with the by-laws of the intergovernmental agency to which they were appointed. For agencies with no defined terms, the appointments shall be made annually in January. Notwithstanding, in all cases, Councilmember assignments and appointments shall terminate automatically when a Councilmember leaves office, effective upon the Councilmember’s last day of service.”

It is not clear why the Council Policy was amended or originally drafted to read as it currently does, but past actions of the City Council recognized the statutory limits on its appointment authority. Since local agency policies cannot override State law, former Councilmember Larson's appointment to BAWSCA will continue until June 30, 2023.

Regarding Council's consideration for the reappointment of former Councilmember Larsson to the BAWSCA Board of Directors to another four-year term, there is no obstacle under state law to make the reappointment. Section I.1 of the Council Policy provides for the appointment of non-Councilmembers to IGR assignments and Section I.1.2 requires a summary written report to be submitted to City Council for each meeting of the intergovernmental agency attended.

FISCAL IMPACT

There is no fiscal impact associated with this report.

COUNCIL POLICY MANUAL

Policy 7.4.12 Council Appointments to Intergovernmental Agencies

POLICY PURPOSE:

It is the purpose of this policy to establish guidelines and standards regarding City resources and support for Councilmembers. This policy is supplementary to and in no way intended to conflict with the City Charter. For further information on this subject, see:

- City Charter, Section 807
- Code of Ethics and Conduct for Elected Officials (available on the City's internal Web site or in the Office of the City Clerk)

Additionally, this policy provides clarity around the appointment of Councilmembers and non-Councilmembers to intergovernmental (IGR) assignments, including appointment criteria, appointment process, and term length. The policy also addresses Council subcommittees and task forces.

POLICY STATEMENT:

I. City Councilmember Appointments to Intergovernmental Agencies

- The City Council appoints members to a variety of intergovernmental agencies in order to represent the City's interests and to influence policies and regulations of other agencies.

In general, appointments are governed by the following principles:

- A. For those IGR assignments where the City's representative serves at the discretion of the Council, the City Council will nominate members to fill vacancies on IGR bodies as part of a noticed agenda item at a regular meeting.
- B. For appointments made by outside bodies (for example, the Cities Association or the League of California Cities), the City Council must ratify the appointment of a Councilmember as part of a noticed agenda item at a regular meeting. No further Council ratification is needed for subcommittee appointments if the appointing committee assignment has already been ratified by Council.
- C. The term of office for the Sunnyvale representative shall be in accordance with the by-laws of the intergovernmental agency to which they were appointed. For agencies with no defined terms, the appointments shall be made annually in January. Notwithstanding, in all cases, Councilmember assignments and appointments shall terminate automatically when a Councilmember leaves office, effective upon the Councilmember's last day of service.
- D. In the event a vacancy occurs during a term, the Council will select a member to serve the remainder of that term as part of a noticed agenda at a regular meeting.

COUNCIL POLICY MANUAL

Councilmembers shall notify the IGR Manager of any changes to IGR assignments.

- E. Council shall appoint a member to serve as an alternate to IGR bodies at the request of the agency or when the nature of the assignment requires a representative always be present.
- F. Staff support is provided to Councilmembers serving on IGR bodies as directed by the City Manager and in accordance with this Policy.
- G. When representing the City on an intergovernmental committee, Councilmembers must vote in accordance with the official City position on an issue, regardless of the Councilmember's individual position.
- H. Cities Association of Santa Clara County (CASCC): City Council Representation

The Cities Association of Santa Clara County was formed in 1990 (formerly the "Intergovernmental Council") in order to represent the mutual interests of the diverse fifteen cities of Santa Clara County and to present a unified voice for the cities in dealing with other agencies, organizations and levels of government. The Association was established through a joint powers agreement, and is funded exclusively by the fifteen cities.

Each city appoints a city Councilmember to the Board of Directors, which meets monthly. In its role as an advocate for the cities, the group monitors legislative activities at the state and federal levels.

The issue of selection of the representative shall be placed on the agenda of the Council meeting following the meeting when the Mayor is selected. By tradition, the Mayor represents the City of Sunnyvale on the Board of Directors. The Mayor has the discretion to designate another Councilmember to serve on the Board of the CASCC in his or her stead.

- I. City Council Appointment of a Non-Councilmember to an IGR Assignment

The City Council may, on occasion, appoint a non-Councilmember to represent the City's interest on an intergovernmental body. These appointments must be made as part of a noticed agenda item at a regular meeting. In those circumstances:

1. Staff support is not provided to non-Councilmembers who serve on an intergovernmental body, although a staff member liaison will be designated by the City Manager.
2. Non-Councilmembers serving on intergovernmental bodies shall provide a summary written report to the entire City Council and the City Manager after each intergovernmental agency meeting they attend.

II. Mayoral Appointments to Intergovernmental Agencies

The Mayor appoints members to a variety of intergovernmental agencies in order to represent the City's interests and to influence policies and regulations of other agencies.

In general, appointments are governed by the following principles:

- A. The Mayor may appoint him/herself.
- B. For those IGR assignments where the City's representative serves at the discretion of the Mayor, the Mayor will appoint members to fill vacancies on IGR bodies.
- C. Mayoral appointments include appointments to the US Conference of Mayors' Policy Committees; Cities Association of Santa Clara County's Board of Directors, City Selection Committee, and Legislative Action Committee; the Advisory Council to the Council on Aging; and Council voting delegates and alternates for annual League of California Cities and National League of Cities conferences.
- D. As vacancies occur to the Mayoral appointment to the Advisory Council to the Council on Aging, the Mayor may direct staff to recommend individuals for consideration.

III. Staff Support to IGR Assignments

Staff assistance shall be provided to Councilmembers serving on intergovernmental bodies when the Council has approved the appointments of a member to that body, or in the case when the Council is not the approving body, if the Council has consented to that member sitting on that body (see Council Policy, 7.3.12 regarding the City Council Appointments to Intergovernmental Agencies, City Council Subcommittees and Council or Mayor-Created Advisory Task Forces). Unless officially approved by the Council, no staff support shall be provided once a Councilmember leaves City office. The City's Intergovernmental Relations (IGR) Program is coordinated within the Office of the City Manager. The Office of the City Manager is responsible for assisting Council with applications for IGR committees, determining levels of staff support, presenting Reports to Council to ratify IGR appointments, and maintaining the Council IGR committee database.

For purposes of this policy, intergovernmental bodies are broadly defined to include committees of intergovernmental agencies or organizations. Staff support shall be consistent with the following guidelines:

- A. Assignments will be made by the City Manager.

- B. If the intergovernmental body has its own professional staff, such staff should be utilized to the greatest practical extent, rather than City staff.
- C. Assigned staff shall meet with newly assigned Councilmembers regarding the expected level of support. A form will be provided to reflect the agreed upon level of support with appropriate signatures. This form is updated at a Councilmember's request, or upon a change in assignment.
- D. Staff shall request that the Councilmember be placed on the committee's mailing list to receive all required information.
- E. Assigned City staff shall not attend the intergovernmental meeting unless the Councilmember requests such attendance from the City Manager, and the Manager approves.
- F. The primary responsibility of assigned staff is to review issues before the intergovernmental body as they may affect the City, and to advise and assist the Councilmember in presenting issues before the full Council. Staff is encouraged to communicate with Council in writing to avoid miscommunication. IGR information provided to Council shall be consistent with adopted City policies (consider General Plan Sub-elements, adopted legislative advocacy positions, or past Council practice).
- G. In the absence of adopted policy, staff should determine whether the issue is significant enough to warrant a Council adopted position. If so, the City Manager should be notified in a timely manner so that the issue can be placed on a Council agenda.
- H. Councilmembers shall not direct staff to conduct major research. Major research shall occur only upon the direction of the City Manager.
- I. As directed by the City Manager, assigned staff may prepare formal IGR correspondence on behalf of Councilmembers only on issues arising from a Councilmember's IGR committee assignment. Always copy the originating department Director, City Manager and IGR Officer on all IGR-related correspondence (For more detail on IGR advocacy correspondence, see Section E: "Correspondence Preparation").
- J. Council may provide updates on their IGR assignments during the Council Updates on Intergovernmental Activities section of the Council agenda.
- K. Legislative Briefings. Staff prepares briefing reports for Councilmembers attending conferences and meetings as directed by the City Manager. Such reports include up-to-date information on the issues at hand. When the subject is to be

discussed with specific legislators, their position (if known on the matter) should be included in the report.

IV. Implementation.

The City Manager shall monitor those provisions of this policy within the City Manager's Charter responsibilities. Disagreement in interpretation shall be resolved by the City Council. The City Manager shall institute administrative policy to implement this policy. At the time a new Councilmember is seated, the Mayor and City Manager should review this policy with him/her.

Annually, the City Manager shall review the resource requirements necessary to support the level of service specified in this policy, and recommend as a part of the proposed budget necessary changes of budget resources.

Determine the 2023 Seating Arrangements for City Council

BACKGROUND AND DISCUSSION

Council Policy 7.3.11 (Attachment 1) provides a process to determine the seating arrangements of Councilmembers at Council meetings. This procedure is conducted as the last item of business at the meeting during which the Vice Mayor is selected. The Mayor will be seated in the center seat, and the Vice Mayor may choose to be seated to either side of the Mayor. The remaining seats will be selected in order of Council seniority as defined in Council Policy 7.3.11.

Section 3.B. of Council Policy 7.3.11 states, "Councilmembers shall select where they wish to sit on the basis of length of continuous time of service on the City Council. The selection process shall be in the order of most senior to least senior. When two or more Councilmembers have equivalent time of service, those Councilmembers are given priority in seat selection by the highest number of votes received in their most recent election." Therefore, after selection of the seats to be occupied by the Mayor and the Vice Mayor, the following order is to be used to select the remaining seats:

On December 12, 2022, Justin Jun-Ren Wang filed a request for a Voter Initiated Recount with the Santa Clara County Registrar of Voters (ROV). On December 27, 2022, the ROV reported the Voter Initiated Recount resulted in a tie between the two candidates. A tiebreaker for City Council District 3 is scheduled for Tuesday, January 3, 2023 (see Attachment 3).

Policy 7.3.11 Seating Arrangements/City Council

POLICY PURPOSE:

Section 613 of the Charter provides that the City Council shall establish rules for the conduct of its proceedings. It is the purpose of this policy to establish a process to determine the seating arrangement of Councilmembers at Council meetings.

POLICY STATEMENT:

1. Seating of Mayor

The Mayor shall be seated in the center seat. Should the Mayor be absent, the Vice Mayor will assume the Mayor's seat.

2. Seating of the Vice Mayor

The Vice Mayor shall be seated to either side of the Mayor, with the vice Mayor receiving preference for obtaining the seat.

3. Councilmember Seating


A. When Determined: Seating arrangements will be determined as the last item of business at a meeting during which a mayor and/or vice mayor is selected.

B. How Determined: Councilmembers shall select where they wish to sit on the basis of length of continuous time of service on the City Council. The selection process shall be in the order of most senior to least senior. When two or more Councilmembers have equivalent time of service, those Councilmembers shall be given priority in seat selection by the highest number of votes in his/her most recent election.

[22-0994](#) Forward a Recommendation to the City Council to Adopt an Ordinance to Amend Chapter 19.50 of Title 19 of the Sunnyvale Municipal Code to Allow Modifications of Legal Non-Conforming Single-Family and Two-Family Dwelling Uses in Non-Residential Zoning Districts (Study Issue 21-01) and Find that the Action is Exempt from the California Environmental Quality Act Pursuant to Guidelines Section 15061(b)(3) (Planning File Number 2022-7591)

Associate Planner Drew Taplin presented the staff report with a slide presentation.

Chair Pyne asked why the parcels on 216 East Arbor Avenue and 1388 Bremerton Drive were not considered for potential rezoning since they are both adjacent to residential zoning districts. Associate Planner Taplin shed some light on the process of rezoning parcels. Principal Planner Amber Blizinski added that since both parcels

are considered within the context of the Village Center and allow for a higher density than residentially zoned parcels, state law would not allow the City to downzone them to a less dense residential zoning district.

Commissioner Serrone confirmed with Principal Planner Blizinski that properties on commercially zoned parcels that will be rezoned residential will lose the ability to designate their property for commercial use. Principal Planner Blizinski added that requests for commercial use on these parcels are less likely to arise because they are privately owned.

Commissioner Weiss confirmed with Associate Planner Taplin that the amendment to Chapter 19.50 of Title 19 of the Sunnyvale Municipal Code (SMC) will apply to the affected parcels rather than the owners of those parcels. Commissioner Weiss received clarification from Principal Planner Blizinski about how this amendment will not result in rezoning parcels or altering their land use designation. Instead, it will allow for the expansion of legal non-conforming single-family or two-family dwellings.

Commissioner Shukla asked whether the amendment of SMC Chapter 19.50 of Title 19 would restrict property owners from developing according to the zoning they are bound by. Associate Planner Taplin explained that this amendment would allow property owners of legal non-conforming single-family or two-family dwellings to expand as well as operate according to their parcel's zoning designation. However, he added that if such parcels were rezoned for residential use, they would not be able to operate commercially.

At Commissioner Shukla's request, Associate Planner Taplin explained how certain parcels were selected for the study issue.

At Chair Pyne's request, Associate Planner Taplin described that the outreach conducted for this study issue involved notice by mail and legal ad publication.

Chair Pyne opened the Public Hearing.

Wesley Yu, Sunnyvale resident, spoke in overall support of amending SMC Chapter 19.50 of Title 19 since this will allow for the expansion of his own property and support the needs of his growing family. He also added that, in his opinion, adjacent parcels to his own would not be feasible for commercial or industrial use due to their small size.

Chair Pyne closed the Public Hearing.

MOTION: Chair Pyne moved and Commissioner Weiss seconded the motion to approve Alternative 1 – Forward a Recommendation to the City Council to introduce an Ordinance (Attachment 3 to the Report) to amend Chapter 19.50 (Nonconforming Buildings and Uses) of Title 19 (Zoning) of the SMC to allow modifications of legal non-conforming single-family and two-family dwelling uses in non-residential zoning districts and find that the project is exempt from the California Environmental Quality Act pursuant to California Environmental Quality Act Guidelines Section 15061(b) (3).

Chair Pyne stated that amending SMC Chapter 19.50 of Title 19 will prove beneficial for affected property owners and improve the ordinance itself.

[22-1033](#) Forward a Recommendation to Adopt an Urgency Interim Ordinance and Introduce an Ordinance Amending Titles 16 (Buildings and Construction) and 19 (Zoning) of the Sunnyvale Municipal Code related to new State Legislation on Accessory Dwelling Units, Parking Minimums, and Large Family Child Care Homes and Find that the Action is Exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Sections 15061(b)(3), 15378(b)(5), Public Resources Codes Section

21080.17 and Health & Safety Code Section 1597.45(d) (Planning File Number 2022-7711).

Principal Planner Amber Blizinski presented the staff report with a slide presentation.

Commissioner Serrone and Principal Planner Blizinski discussed size requirements for accessory dwelling units (ADU) when considering the floor area ratio of single-family dwelling units. Principal Planner Blizinski also confirmed that second story detached ADUs are not permitted in the City if they cannot fit within the new height maximums.

Principal Planner Blizinski provided a brief explanation on proposed section G of Sunnyvale Municipal Code (SMC) 19.79.020, found on page 12 of Attachment 2, for Commissioner Serrone. She also clarified parking lot design requirements stipulated in SMC Chapter 19.46. Lastly, Principal Planner Blizinski confirmed that the map showing major transit stops is often updated to reflect changes that occur.

Commissioner Serrone questioned whether childcare services may be provided from an apartment. Principal Planner Blizinski responded that facilities that offer childcare services must follow fire and state licensing requirements and that apartments are often not likely to meet these requirements due to their layout. She also offered clarification on parking requirements for commercial childcare centers versus those for family day care centers that are operated from a home.

Commissioner Weiss confirmed with Principal Planner Blizinski that there are no staffing concerns for meeting ADU permit review requirements.

Commissioner Shukla asked whether the maximum height requirement for ADUs prohibits the development of two-story ADUs. Principal Planner Blizinski answered that if the ADU complies with City requirements for height, square footage, and the like, an ADU that is greater than one story may be allowed.

At Chair Pyne's request, Principal Planner Blizinski explained section B.3 of SMC Chapter 19.46.030.

Chair Pyne noted that a lot of exempted parking areas are located in the Moffett Park area and questioned whether this will impact the Moffett Park Specific Plan (MPSP). Principal Planner Blizinski advised that the Project Planner overseeing the MPSP, Michelle King, is aware of the new legislation and it is likely being

considered.

Chair Pyne confirmed with Principal Planner Blizinski that the Planning Commission will review AB 2011 and SB 6 and forward recommendations to the City Council at some point.

At Commissioner Shukla's request, Principal Planner Blizinski explained what is meant by "urgency interim ordinance," clarified why one is needed, and provided an overview of the process for adopting an ordinance.

Chair Pyne opened the Public Hearing.

There were no public speakers for this agenda item.

Chair Pyne closed the Public Hearing.

c) Find that these actions are exempt from CEQA pursuant to CEQA Guidelines Sections 15061(b)(3), 15378(b)(5), Public Resources Codes Section 21080.17 and Health & Safety Code Section 1597.45(d).

2. Actions pertaining to Parking

The attached memorandum was prepared by Councilmember Hendricks and is being distributed to Council at his request.

Ten Thoughts on Being a Council Member

1. **Have fun** – Being a member of the Sunnyvale City Council is a lot of work, an intense responsibility and a great honor. But, just like anything else in life, you need to enjoy what you are doing. If you ever get to the point, where you are not enjoying yourself in this role – you need to reconsider if being a Council Member is for you. I guarantee, you cannot do a great job for the residents of the City, if you don't enjoy being on the Council.
2. **Remain Humble** - Take the role of Council Member very seriously, but don't take yourself too seriously in the role. Don't let your ego take over. Don't let the role of the office, go to your head. You're human, you don't know everything and you will make mistakes. Make sure you learn from everything you do.
3. **Listen** – The best tool you have; is the ability to truly listen to people. And then process what you hear and learn. That doesn't mean you have to do everything a Member of the Public tells you, but you do need to think about what they say and put it in the proper perspective.
4. **Be concise** – You are going to be given many opportunities to speak to individuals and groups. Be respectful of their time, get to the point of what you want to tell them. Don't drone on with stories that don't help your point. (OK, I may not have always followed this one).
5. **Have a purpose when you speak in a Council Meeting** – I have learned there are only three times to talk during a Council meeting.
 - a. **Ask a question, when you don't know the answer.** This is kind of self-evident. The part that is not self-evident; this shouldn't happen very often. Be engaged, be curious, do your research. Read the Staff Report.
 - b. **Ask the question, when you do know the answer.** Do this when you know the answer and you want to make sure your colleagues and the public learn the answer.
 - c. **Advocate/Explain.** After the public hearing, and you have heard from the public – then it is time to advocate a position to your colleagues. You also want to explain to the public why you have voted the way you have.

6. **Zoom-in/Zoom-out** - You have to be able to **Zoom-in** to the details of a topic and get enough information to make a decision. (You don't have to learn everything). But, remember to **Zoom-out** to the macro picture. Stay strategic and remember, the Council is generally making a Policy Decision. The tactics and operational implementation are Staff's responsibility.
7. **Be a Cheerleader** – You need to be the biggest supporter and cheerleader for the City, businesses and people of Sunnyvale. Understand the warts and issues of the City (and work to improve them), but always be a positive voice for the City.
8. **Support our employees** – The role of the City of Sunnyvale is to provide services to our residents. Our employees are the ones that provide those services. (And they do a great job at this). Be supportive of our employees, acknowledge the great work they do, and give them the appropriate tools to let them continue giving great services to our residents.
9. **Remember your role** – Remember your job is Vision, Direction, Policy and Budget. Stay within the bounds of your role. Take a strategic view of what you are doing. Be careful of expanding the reach of Sunnyvale governance into areas that are really not its purview. Be cautious of expanding the financial reach of our budget.
10. **Think strategically about Sunnyvale's role in the County and Region** – Sunnyvale is the second largest City in the County. Our Council has the ability and responsibility to provide useful and appropriate perspective/leadership on Regional issues. Use this voice with responsibility but do not over-reach. Remember your first responsibility is to Sunnyvale and keeping it a positive example; so that you can have credibility to speak on these larger Regional topics.
