REPORT TO SUCCESSOR AGENCY BOARD

SUBJECT

Designation of the Authorized Officers of the Successor Agency to the Former Redevelopment Agency of the City of Sunnyvale and Establishing the Procedures for the Conduct of the Successor Agency Business

DISCUSSION

The Redevelopment Agency of the City of Sunnyvale was dissolved pursuant to the Redevelopment Dissolution Act (AB 1x 26, as amended by AB 1484 and as further amended by SB 107) on February 1, 2012. Prior to it dissolution and in accordance with the provisions of the Dissolution Act, the City of Sunnyvale elected to act as the Successor Agency to the former Redevelopment Agency. AB 1484 which amended the original Dissolution Act, made clear that the Successor Agency is a separate public entity from the City. Since the enactment of AB 1484 the Successor Agency has had limited need to meet and when it has met has functioned in accordance with the rules governing the City of Sunnyvale for the conduct of meetings. In order to ensure that the business of the Successor Agency is being conducted in accordance with appropriate procedures, the City staff is proposing that the Successor Agency adopt procedures for the conduct of the Successor Agency business, including designating the officers of the Successor Agency, the quorum requirements for meetings of the Successor Agency and vote requirements for actions of the Successor Agency.

The attached resolution designates the City Council as the governing body of the Successor Agency and designates that the Mayor of the City shall act as chair of the Successor Agency. The Vice-Mayor is designated to act as the vice-chair of the Successor Agency. The resolution also designates that the City Manager shall act as the Executive Director of the Successor Agency and the City Finance Director shall act as the Treasurer of the Successor Agency. The City Clerk will act as the Secretary of the Successor Agency Attorney.

The attached resolution also provides that regular meeting of the Successor Agency will be held at the same time and day as the City Council regular meeting and will be conducted in accordance with the procedures for the conduct of City Council meetings. A majority of the members of the Successor Agency shall be necessary for a quorum at a meeting and a majority of those present and voting shall be required for the Successor Agency to take any action.

ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" with the meaning of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378 (b) (5) in that it is a governmental organizational or administrative activity that will not result in direct or indirect changes in the environment.



RESOLUTION NO. -16-RSA

A RESOLUTION OF THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF SUNNYVALE DESIGNATING THE AUTHORIZED OFFICERS OF THE SUCCESSOR AGENCY AND PROCEDURES FOR THE CONDUCT OF SUCCESSOR AGENCY BUSINESS

WHEREAS, Assembly Bill 1X 26 (the "Dissolution Act"), enacted on June 28, 2011 resulted in the dissolution of all redevelopment agencies in the State of California, including the Redevelopment Agency of the City of Sunnyvale (the "Former RDA") effective February 1, 2012; and

WHEREAS, in accordance with the Dissolution Act, the City of Sunnyvale (the "City") elected to act as the Successor Agency to the Former RDA; and

WHEREAS, Assembly Bill 1484 enacted on June 27, 2012 amended the Dissolution Act and affirmed that the Successor Agency is a separate legal entity from the City; and

WHEREAS, the Successor Agency now desires to designate the authorized officers of the Successor Agency, to set regular meeting times and to establish the procedures for the conduct of meetings of the governing body.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Sunnyvale shall act as the governing board of the Successor Agency; and

BE IT FURTHER RESOLVED, that the Mayor of the City shall be the Chair of the Successor Agency, the Vice-Mayor shall be the Vice-Chair of the Successor Agency; and

BE IT FURTHER RESOLVED, that the City Manager of the City shall act as the Executive Director of the Successor Agency, the City Finance Director shall act as the Treasurer and the City Clerk shall act as the Secretary of the Successor Agency and the City Attorney shall act as Successor Agency Attorney; and

BE IT FURTHER RESOLVED, that the Successor Agency Governing Board shall hold its regular meetings on the same days and at the same time as the regularly scheduled City Council meetings, provided however, that the Chair in consultation with the Executive Director may cancel any such regularly scheduled meetings of the Successor Agency if the Chair determines that there is no need for the Successor Agency Governing Board to meet; and

BE IT FURTHER RESOLVED, that the Chair or the Vice-Chair, in the Chair's absence, may call special meetings of the Successor Agency Governing Board upon twenty-four hours' notice given in accordance with the requirement of the Brown Act (Government Code Section 54950 et seq.); and

BE IT FURTHER RESOLVED, that meetings of the Successor Agency Governing Board shall be conducted in accordance with the procedures governing meetings of the City Council of the City; and

BE IT FURTHER RESOLVED, that a majority of the members of the Successor Agency shall constitute a quorum for the transaction of business; and

BE IT FURTHE RESOLVED, all actions of the Successor Agency Governing Board shall require the affirmative vote of a majority of the members of the Governing Board present and voting at a duly called meeting.
