### 2 <u>16-0612</u> Overview of Harwood Public Innovators Lab Training

Director Bojorguez commented that staff members recently attended the Harwood Public Innovator's Lab training. Director Bojorquez welcomed Librarian Christina Shin to the meeting. Librarian Shin provided the Board with an overview of the training that took place May 23-25 in Sacramento. Approximately 100 library professionals attended the training which ncluded: librarians, directors, administrators, library trustee members and council members. The training is based on Harwood's "Libraries Transform" campaign that focuses on transitioning libraries from being an inward focus organization to an outward focus organization. It also focuses on helping libraries build relationships with their communities and how to serve their communities outside of the library building. Staff have identified short-term goals and have established an action plan to help assist with applying some of Harwood's practices for the Branch Library Project. Board Members expressed their enthusiasm regarding the campaign and inquired if staff would be training City Council and other City staff. Director Bojorquez indicated that the immediate focus will be to train a team of Library and Community Services staff and have them build a relationship with North Sunnyvale.

Chair Shanmugasundaram opend the public hearing, and there being no public comments, closed the public hearing.
