GENERAL BUSINESS

[18-0108](#) Introduction to Ideation and Preview of CAP 2.0 Ideas
Workshop

Scott Shigeoka, Senior Community Designer at OpenIDEO, guided the CAC through the ideation process that would be followed at the Innovate Climate Action in Sunnyvale Workshop on March 3 (“Workshop”). Mr. Shigeoka explained what human-centered design was, provided examples of well- and poorly-designed ideas, and provided the framework for the ideation exercises for the meeting. CAC members asked several clarification questions and provided suggestions.

CAC members worked in smaller groups to develop ideas in the four opportunity areas (same as those on the online CAP 2.0 platform): energy; mobility; conserving and consuming resources; and data and technology. CAC provided suggestions of organizations that might be critical for the City to partner with for CAP 2.0 implementation, including business groups, non-profits, and others.

Mr. Shigeoka invited CAC members to volunteer to serve as: (1) Table captains for the Workshop to facilitate the ideation process for a small group; (2) Presenters of a 4-minute talk at the Workshop; and (3) Workshop Leaders who be trained to conduct smaller versions of the ideation workshop in the community. Workshop leaders and table captains would be trained by OpenIDEO.
