2 19-0050 Rank Study Issues

Superintendent of Parks and Golf, Jim Stark, provided an overview of Study Issues ESD17-01 and DPW19-07.

Staff responded to Commissioner's questions regarding review and modifications of Study Issues. Staff stated that Study Issues being ranked by the Commission have no mechanism for prior review and that edits cannot be made at the time of ranking.

Staff responded to Commissioner's questions regarding the difference between youth and adult Cricket batting cages, potential locations and next steps. It was agreed that the cages are functional for all ages and that all open space areas will be looked at. Staff also indicated the process and timeline should the Study Issue be ranked above the line by Council at their annual meeting.
