Calendar 2022 Highlights

- 25 Registered Neighborhood Associations (4 new)
- Art and Wine Festival exceeded attendance projection by 40% (approx. 35,000 – 40,000 attendees)
- San Miguel PTA doubled free Zumba classes to two per week and annual Multi-Cultural Night had over 300 attendees





Calendar 2022 Highlights (continued)

- SDA Magic of Sunnyvale Wine Stroll paired 15 wineries and businesses and brought in new businesses including Cityline retail
- Bike to Wherever Day 3,700 registered for event, Sunnyvale Farmer's Market was one of the most popular energizer stations (out of 150)
- "Find Love in Sunnyvale" Scavenger Hunt – 45 residents formally entered the contest, 200+ Instagram posts and dozens on Facebook, helped to create sense of community and spirit

Feedback from Grantees on Grant Process

- 3. Suggestions on how to improve the 2023 grant application process:
- Takes a lot of staff time to provide a full event budget and receipts. Grant amount awarded is not comparable to staff time required to administer grant.
- Widely promote grant opportunities and specifically target community groups.
- Conduct survey and create grants to address community events/needs.
- Difficult to project more than a year out for volunteer-run Neighborhood Associations. Would suggest two funding cycles throughout the year.
- Provide a YouTube video on the whole neighborhood/community event process.

Feedback from Grantees on Grant Process

4. Other feedback/ideas you'll like to share:

- Mailing list for future grant application info.
- Details on why the funding amount changed so much from \$5K (2021) to \$2K (2022).
- Please allocate funds independent of grant funding for neighborhood security (for cameras, continued monitoring, signs etc.).
- A resources page on who to contact for help or questions.
- Make it shorter!!

CY 2023 Proposed Updates

- Schedule 2 meetings (virtual & optional) each to answer questions about Community Events & Neighborhood Grants
- Create FAQs from virtual meetings and post on City website
- Require all grant recipients to acknowledge City as funder in all marketing and outreach materials (i.e., fliers, social media, posters, etc.)
- Focus outreach for new Neighborhood Associations (NA) in areas/districts with fewer registered NA
- Add a question in final report requesting feedback on grant program process (application, communication reimbursements, etc.)
