A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE APPOINTING LINDA SELL TO THE CITY COUNCIL TO REPRESENT COUNSIL DISTRICT 1 FOR A FULL-TERM OF FOUR YEARS BEGINNING IN 2023 IN LIEU OF AN ELECTION; AND CANCELLING THE NOVEMBER 8, 2022, GENERAL MUNICIPAL ELECTION FOR CITY COUNCILMEMBER COUNCIL DISTRICT 1, PURSUANT TO CALIFORNIA ELECTIONS CODE SECTION 10229

WHEREAS on June 7, 2022, the City Council adopted Resolution No. 1120-22, calling and giving notice of the holding of a general municipal election for the purpose of electing one person each from Council Districts 1, 3, and 5 to the City Council of the City of Sunnyvale for full four-year terms; and

WHEREAS, as of the close of the nomination period on Friday, August 12, 2022, only one person filed nomination papers to run for the office of City Councilmember representing District 1; and

WHEREAS, Section 10229 of the California Elections Code allows the City Council to take one of the following courses of action when only one person has filed nomination papers for an office: (1) Appoint to the office the person who has been nominated, or (2) hold the election if either no one or only one person has been nominated.

WHEREAS, pursuant to Section 10229 of the California Elections Code, a notice, (Proof of Publication), herein attached and incorporated by reference as Exhibit "A", was published on August 17, 2022, in the San Jose Mercury News, certifying these facts and the options available to the City Council; and

WHEREAS, pursuant to Section 10229 of the California Elections Code, if by the 75th day before the scheduled General Municipal Election (August 25, 2022), no person has been appointed to this office pursuant to (1) above, the election for Council District 1 is required to be held along with all other elective offices on the ballot. If an appointment is made to this office, the General Municipal Election for Council District 1 must be cancelled, but the General Municipal Election will be held for all other elective offices on the ballot; and

WHEREAS, if the City Council makes an appointment pursuant to Section 10229 of the California Elections Code, the City Clerk/Elections Official shall not accept for filing any statement of write-in candidacy for City Councilmember from Council District No. 1 which is submitted after the appointment is made; and

WHEREAS, cancelling the uncontested election for Council District 1 will save the City the unnecessary costs of holding that uncontested election; and

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

- 1. That the above recitals are true and correct.
- 2. Pursuant to Section 10229 of the California Elections Code, the following action is taken:

The following person is appointed to the office to which she was nominated, and is considered to be the same as being elected, pursuant to Section 10229(a) of the California Elections Code:

- 3. Pursuant to Elections Code Section 10229, the General Municipal Election scheduled to be held on Tuesday, November 8, 2022, to elect a candidate for City Council Member from Council District 1 is hereby cancelled because only one person is nominated to be elected in that District, and the City Council has made the above appointment. The General Municipal Election shall still be held to elect candidates for City Council Member from Council Districts 3 and 5.
- SECTION 4. The person appointed shall qualify and take office and serve exactly as if elected at the General Municipal Election for the office.

SECTION 5. The City Clerk shall certify to the passage and adoption of this Resolution and so notify the Santa Clara County Registrar of Voters and Board of Supervisors of the City Council's action, and is authorized to take any other administrative actions necessary to cancel the 2022 general municipal election for Council District 1.

CITY OF SUNNYVALE NOTICE OF CITY CLERK'S CERTIFICATION THAT THERE ARE NOT MORE CANDIDATES THAN OFFICES TO BE ELECTED

NOTICE IS HEREBY GIVEN, pursuant to Section 10229 of the Elections Code of the State of California, to the following facts relating to the general municipal election to be held on Tuesday, November 8, 2022:

As of the close of the nomination period on August 12, 2022 for the election of one (1) Member of the Councilmember District No. 1 of said City for the full term of four (4) years, there are not more candidates than offices to be elected.

The person so nominated is: Linda Sell Mother / Engineer

That Section 10229 of the Elections Code allows one of the following courses of action to be taken by the City Council:

Appoint to the office the person who has been nominated.
Appoint to the office any eligible voter if no one has been nominated.
Hold the election if either no one or only one person has been nominated.

On August 22, 2022, the City Council will meet to either make the appointments or direct an election to be held. The persons appointed, if any, shall qualify and take office and serve exactly as if elected at a municipal election for the office. If, by the 75th day before the municipal election, no person has been appointed to the office(s) pursuant to (1) or (2) above, the election shall be held for such office(s).

If the City Council makes an appointment pursuant to Section 10229 of the Elections Code, the City Clerk shall not accept for filing any statement of write in candidacy which is submitted after the appointment is made.
