## **GENERAL BUSINESS**

- 2      [22-0655](#)      Discussion and Possible Recommendation to the City Council Regarding Updates to Council Policy 7.2.19 (Boards and Commissions) Including: Timing of Appointments for Incumbent Members; Bicycle and Pedestrian Advisory Commission Categories; and Sustainability Commission Category Two Description

City Clerk David Carnahan provided the staff report.

The Subcommittee discussed or suggested recommendations regarding Council Policy 7.2.19:

- Support for adding a section that addresses appointing a sitting board/commission member to a vacant term. Section may include language about concurrent service while transitioning to a different board or commission.
- Comment that the transition period/concurrent service should be no longer than 60 days from appointment date.
- Concern was expressed with the possibility of a member who is serving concurrent service voting twice on a specific item while serving on two boards/commissions.
- Suggestion that language about concurrent service include that a member will recuse themselves from any agenda item they may have previously voted on while serving on a different board or commission.
- Support to include language that once a member takes their oath of office for their new commission it will be deemed as a resignation from their first board or commission.
- Comment that the Code of Ethics and Conduct for Appointed and Elected Officials includes language that a member will recuse themselves from an agenda item when a conflict of interest exists.
- Support for removing Categories I and II from the Bicycle and Pedestrian Advisory Commission (BPAC). Categories I and II for the Sustainability Commission should remain as is.
- Support for leaving Categories I and II for BPAC but add that each category may have up to four members for Category I and three members for Category II.
- Support for adding a maximum of two members for BPAC Category II and is non-Sunnyvale resident.

- Suggestion to remove “members of neighborhood associations” from BPAC Category II.
