





Proposal for Lobby Artwork for the Sunnyvale City Hall

Sunnyvale Art Commission

Title of Proposed Artwork: "The Unity of the Opposites"

Narrative:

Our proposal includes the design for a mixed-media mural artwork, 5'x 9', for the lobby wall niche at the new Sunnyvale City Hall. The theme is a visual diversion inspired by the notion of the unity of opposites, or non duality. The design is basically divided into opposing sections: one consisting of straight lines, smooth surfaces, and only colored in black and white, representing form and order; and the other, in contrast, symbolizes matter, which has curved elements, rough surfaces, and a wide variety of colors. Nonetheless, there exist elements of the other, the opposite, within each partition, i.e., a connection. The idea is that the existence, or identity, of a thing, or situation, depends on the co-existence of an opposing object; that these contradicting forces do not cancel each other out, but actually are dependent on, and accept, each other. We feel that this concept relates very well with the City's vision of equity, access, and inclusion and its brand essence: Bold, Sustainable, and Innovative.

Size: The dimensions of the artwork would be 5' x 9' which would be placed allowing for a one foot gap on the top and sides, and a two foot gap on the bottom of the niche.

Medium: Mixed-media, consisting of diverse materials, in particular reclaimed, including, but not limited to wood, stone, metal, fabric, and painted surfaces, As in previous work, we prefer to incorporate a wide variety of materials and textures into our artwork. The use of mixed-media would be essential in the development of our concept for this project as stated above providing both contrast and distinction. The use of varied materials would result in a stunning contemporary artwork with incredible intensity, color and richness. The utmost care in the choice of appropriate materials and methods would be given to assure the highest quality and to keep the weight of the artwork under the required 175 pounds.

Maintenance Requirements: The artwork would be very durable, sustainable, and would not require any foreseeable maintenance. It would only require periodic inspection.


Lighting Requirements: There would not be any extra lighting needed besides the LED strip with the spotlights as described in the Lobby Art FAQ's selection letter.
