A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE AMENDING RESOLUTION NOS. 143-77 AND 1151-22, TO ADD TWO NEW INFORMATION TECHNOLOGY CLASSIFICATIONS TO THE CLASSIFICATION PLAN OF THE CIVIL SERVICE, AND TO AMEND THE CITY'S SALARY RESOLUTION TO UPDATE THE SCHEDULE OF PAY TO INCLUDE THOSE CLASSIFICATIONS AND INCREASE SALARIES FOR THE POSITIONS OF CLIENT SUPPORT SPECIALIST I/II

WHEREAS, at the request of the Information Technology Department, the Human Resources staff has proposed an amendment to the Classification Plan of the Civil Service of the City of Sunnyvale to add the newly established job classifications of "Senior Client Support Specialist" and "Principal Client Support Specialist" to create potential future promotional opportunities; and

WHEREAS, the City Council having considered such proposals and recommendations desire to approve the amendment to the Classification Plan of the Civil Service and make corresponding changes to the City's Salary Resolution to update salaries for the Client Support Specialist series of positions.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

1. The City Council hereby approves an amendment to the Classification Plan of the Civil Service as follows:
 - a. Create the classification of Senior Client Support Specialist (2447) with a pay range of \$94,873 (Min. range/ Step 1) to \$121,091 (Max. range/ Step 6) annually.
 - b. Create the classification of Principal Client Support Specialist (2448) with a pay range of \$111,950 (Min. range/ Step 1) to \$142,880 (Max. range/ Step 6) annually.
2. Except as herein modified, the Classification Plan, Resolution No. 143-77, as amended, shall remain in full force and effect.
3. Resolution No. 1151-22 (the City's Salary Resolution) is hereby amended as set forth in Exhibit A by adding the classifications and pay rates for Senior and Principal Client Support Specialist and updating the pay rates for Client Support Specialist I/II, to the schedule of pay (salary table), attached and incorporated by reference, to implement the changes described in this resolution on the effective dates noted in Exhibit A. Except as herein modified, Resolution No. 1151-22, as amended, shall remain in full force and effect.
