





Western Alternative




Pros:

- One tunnel
- Straight
- Shorter


Cons:

- More utilities
- Construction staging in roadways
- Small skylight option
- Tree loss in Central median

Eastern Alternative



Eastern Alternative



Pros:

- Less utilities
- Opening in middle lets in air and light
- Open space for construction staging
- Less tree loss

Cons:

- Two tunnel segments
- Visibility
- Longer



Community Meeting, Feb. 2, 2023

- Significant outreach effort
- Supportive of project
- Eastern option preferred
 - Mid-crossing opening
 - Natural light
 - Less expensive
 - Drainage concerns
- Other comments:
 - Separation of bicyclists and pedestrians
 - Flatten ramp areas
 - Concerns about sharp turns
 - Protect ramp openings



Mountain View BPAC Meeting, Feb. 22, 2023



- Supportive of project
- Comments:
 - Most like midway opening
 - Ramp and tunnel widths
 - Connections to roadways
 - Compatibility with Evelyn Avenue plans
 - Prefer no bollards or chicanes
- Passed motion to recommend eastern option
 - 4 in favor
 - 1 abstention

Sunnyvale BPAC Meeting, March 16, 2023

- Supportive of project
- Comments:
 - Like midway opening
 - Interest in protected intersection
 - Compatibility with Evelyn Avenue plans
 - Concerns about sharp turns at tunnel





- Interest in including art
- Passed motion to recommend eastern option to Sunnyvale City Council
 - 5 in favor
 - 1 absence

Mountain View Council Transportation Committee Meeting, April 10, 2023



- Supportive of project
- Comments:
 - Like eastern option
 - Interest in funding plan
 - Interest in including art
 - Include safety/security considerations

 Passed motion to recommend eastern option to Mountain View City Council

3 in favor

Mountain View City Council Meeting, April 25, 2023


- Consent calendar
- No public comments
- No Councilmember comments
- Passed on consent to recommend eastern option
 - 7 in favor



- Finalize Caltrain Agreement
- Complete environmental clearance
- Caltrain to develop Request for Proposals for final design
- Secure remaining funding
 - Approximate gap of \$44M
