

- Moffett Park Specific Plan Adopted

  - Capacity for 17,158 units (143% of RHNA)

- Objective Design Standards for Multi-family/Mixed Use Adopted
- Tenant Protections/Right-To-Lease Ordinance Adopted
- \$1.5M in Programs to Address Homelessness
  - WorkFirst Sunnyvale, Tenant-Based Rental Assistance

## Housing Element Program Achievements (cont.)

- 20 BMR homes sold
- 2 First Time Home Buyer loans provided
- 22 Minor Home Improvement Loans/Grants awarded
  - \* Emergency repair, home access, roof grants, etc.
- Construction closing for 1178 Sonora Court
  - 176 unit lower-income affordable housing project
- ❖\$490K awarded to rehab Carroll Inn SRO project
- 295 S Mathilda purchased for future MidPen affordable housing development
  - 25% of units for families experiencing homelessness
