A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE FOR PAYING AND REPORTING THE VALUE OF **EMPLOYER** PAID **MEMBER CONTRIBUTIONS** TO THE **CALIFORNIA PUBLIC EMPLOYEES'** RETIREMENT **SYSTEM** FOR MANAGEMENT, UNREPRESENTED **CLASSIFIED** UNREPRESENTED UNCLASSIFIED MANAGEMENT AND DEPARTMENT DIRECTORS

WHEREAS, the governing body of the City of Sunnyvale (the City) has the authority to implement Government Code Section 20636(c)(4) pursuant to Section 20691;

WHEREAS, the City has a written labor policy or agreement which specifically provides for the normal member contributions to be paid by the employer, and reported as additional compensation;

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the City of a Resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC);

WHEREAS, the City has identified the following conditions for the purpose of its election to pay EPMC;

- 1. This benefit shall apply to all Unrepresented Classified Management, Unrepresented Unclassified Management and Department Directors.
- 2. This benefit shall consist of paying the following percentage of the normal member contributions as EPMC:
 - a) Effective August 31, 2014, for employees who are classic CalPERS members in Tiers 1 and 2, four percent (4%) employer paid, and reporting the same percent (value) of compensation earnable [excluding Government Code Section 20636(c) (4)] as additional compensation; and
 - b) Effective the first full pay period in Fiscal Year 2015/2016, for employees who are classic CalPERS members in Tiers 1 and 2, three percent (3%) employer paid, and reporting the same percent (value) of compensation earnable [excluding Government Code Section 20636(c)(4)] as additional compensation; and

- c) Effective the first full pay period in Fiscal Year 2016/2017, for employees who are classic CalPERS members in Tiers 1 and 2, two percent (2%) employer paid, and reporting the same percent (value) of compensation earnable [excluding Government Code Section 20636(c)(4)] as additional compensation.
- 3. The effective date of this Resolution is August 31, 2014.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT it hereby elects to pay and report the value of EPMC as set forth above.
