## 2 <u>15-0795</u> Update on Arts Master Plan

Community Services Coordinator Kristin Dance provided information about the process to create a master plan for public art. Council has approved a maximum of \$65,000 to create a written plan which defines and directs expenditures for the Public Art Fund. She reviewed various components of art master plans and asked Commissioners to discuss their priorities if the budget allows for additional components. Commissioners identified the following priorities: determine the economic impact of the arts in Sunnyvale; create an accessible and interactive inventory of the current art in the City; review programming which will increase the level of art and culture available to the Community; revitalize art with the younger generations; and create partnerships with businesses to benefit the community and increase art in the City.
